The Panel received a report that presented 25 Facility, Community and Economic Development, Small Revenue and Spotlight grant applications under the Corporate Grants Schemes.

During consideration of the items the Panel raised a number of points which Officers clarified.

The Panel noted that the awards to the Church of the Transfiguration, Pyecombe and Turners Hill Parish Council exceeded the maximum grant of £5,000 for the schemes as detailed in the guidelines. They also noted that there are no S106 contributions available for capital improvements to community facilities in Pyecombe and Turners Hill.

The Panel considered the application from Crawley Down Football Club and did not think it was appropriate to use Section 106 funding for the catering unit, but agreed to fund the full cost of the grounds maintenance equipment as good maintenance will increase the playing capacity.

With regard to the application from Turners Hill Parish Council, the Panel recognised that the building is currently well used but needs refurbishment to ensure it remains popular and as a result decided to offer the full amount (exclusive of VAT) needed to complete the works.

When considering the application from the Cuckfield Lawn Tennis Club for court dividing nets, a Member sought clarification on who would benefit from the netting and the Panel agreed that consideration of this item be deferred pending clarification from the Club that it is

a non-profit making organisation. The Panel agreed that the Chairman of the Panel be delegated to grant the award.

RESOLVED

That:-

(1) a Facility Grant of £3,242 (75% of the total project cost) be awarded to the East Grinstead Tennis Squash and Racketball Club to purchase cavity wall insulation, which is made up of £3,046 (P35/680 Land at Dunnings Squash Club) and £196 (P35/602 Dunnings Mill Snooker Club) Section 106 Formal sports monies. This will leave a shortfall of £1.081 which will need to be met by reducing expenditure and/or increased local fundraising.

This grant offer be made, subject to the following special conditions:

- (b) the project being completed within 12 months of project funding being obtained;
- (3) a Facility Grant of £15,000 be awarded to Crawley Down Gatwick Football Club towards the cost of grounds maintenance equipment which is made up of £11,994 (P35/728 Land South of Grange Road) Section 106 Formal sport monies.

This grant offer be made subject to the following special conditions:

- (a) that it can be demonstrated that the project can be funded in its entirety within 12 months of the grant offer;
- (b) the project being completed within 12 months of project funding being obtained:
- (c) details of a lease/licence agreement with the Council regarding the main pitch; and
- (d) submission of 2013/14 financial accounts;
- (4) a Facility Grant of £1,000 (11% of the total project cost) be awarded to Felbridge and Sunnyside Cricket Club to purchase grounds maintenance equipment, which is made up of £1,000 (P35/501 Land at Mariners and Redwood) Section 106 Formal sport monies.

This grant offer be made, subject to the following special conditions:

(a) that it can be demonstrated that the project can be funded in its entirety within

- 12 months of the grant offer; and
- (b) the project being completed within 12 months of project funding being obtained:
- (5) a Facility Grant of £500 (16% of the total project cost) be awarded to Crawley Down Cricket Club to upgrade the outdoor cricket nets which is made up of £500 (P35/654 Land at Burleigh Infant School) Section 106 Formal sport monies.

This grant offer be made, subject to the following special conditions:

- (a) that it can be demonstrated that the project can be funded in its entirety within 12 months of the grant offer; and
- (b) the project being completed within 12 months of project funding being obtained;
- (6) a Facility Grant of £62,799 (100% of the total project cost) be awarded to Worth Parish Council to build a new car park in Crawley Down, which is made up of £5,785 (P35/654 Land at Burleigh Infant School), £4,620 (P35/690 Land at Palmers Auto Centre), £615 (P35/717 Land at Haven Farm) and £51,779 (P35/728 Land South of Grange Road) Section 106 Local Community Infrastructure Fund contributions:

- (7) a Facility Grant of £9,000 (18% of the total project cost) be awarded to Bolnore Village Community Partnership to purchase equipment and cover the start-up costs for the new Woodside pavilion which is made up of £9,000 (P35/595) Phases 4 and 5 Leisure contributions which are ring-fenced for use at the Bolnore Recreation Ground.

This grant offer be made, subject to the following conditions:

- (a) that it can be demonstrated that the project can be funded in its entirety within 12 months of the grant offer; and
- (b) the project being completed within 12 months of project funding being obtained;
- (8) a Community and Economic Development Grant of £4,000 be awarded to the Hassocks Community Partnership towards the cost of extra opening hours (pilot project).

This grant offer be made, subject to the following conditions:

- (a) that it can be demonstrated that the project can be funded in its entirety by March 2015; and
- (b) the project being completed by September 2015;
- (9) a Community and Economic Development Grant of £12,265 be awarded to the Church of the Transfiguration, Pyecombe, towards the cost of a new kitchen, plumbing, electrical work and CCTV.

This grant offer be made, subject to the following conditions:

- (a) that it can be demonstrated that the project can be funded in its entirety within 12 months of the grant offer; and
- (b) the project being completed within 12 months of project funding being obtained:
- (10) a Community and Economic Development Grant of £1,909 (75% of the total project cost) be awarded to the Hassocks Community Association to purchase new curtains for Adastra Hall.

This grant offer be made, subject to the following conditions:

- (a) that it can be demonstrated that the project can be funded in its entirety within 12 months of the grant offer; and
- (b) the project being completed within 12 months of project funding being obtained;
- (11) a Community and Economic Development Grant of £18,307 (100% of the total project cost) be awarded to Turners Hill Parish Council to refurbish the Ark village hall.

This grant offer be made, subject to the following conditions:

- (a) that it can be demonstrated that the project can be funded in its entirety within 12 months of the grant offer; and
- (b) the project being completed within 12 months of project funding being obtained;
- (12) a Community and Economic Development Grant of £1,000 be awarded to Burgess Hill Town Council to install a memorial stone and hold a commemorative event to remember Mr. Arthur A. Ghislain Patiny.
 - This grant offer be made, subject to the special condition that the project must be completed within 12 months of project funding being obtained;
- (13) a Community and Economic Development Grant of £500 be awarded to Haywards Heath Town Council Community Interest Company (CIC) to enable them to run a community event in the town in September 2014;
- (14) no grant award be made to the Haywards Heath Town Team Community Interest Comp any (CIC) for a contribution towards the 2015 Haywards Heath Bike Ride event;
- (15) a grant of £3,000 be awarded to the Circles Network as a contribution towards setting up three rural Time Banks;
- (16) a grant of £250 be awarded to the East Grinstead Flower Club as a contribution towards Flowers in the Sought Community event;
- (17) a grant of £500 be awarded to Mid Sussex Sinfonia towards the cost of the Children's Open Day;
