15. Notice of Motion under Council Procedure Rule 11, proposed by Councillor Pete Bradbury and seconded by Councillor John Wilkinson:

Fixed Odds Betting Terminals

Mid Sussex District Council notes:

- (1) The prevalence of Fixed Odds Betting Terminals (FOBTs) in betting shops.
- (2) That, unlike fruit machines in pubs, bingo halls and amusement arcades, where cash stakes are limited to £2, gamblers can bet with cash or via a debit card up to £100 every 20 seconds on FOBTs.
- (3) Research carried out by 2CV, which found that the average bet per spin on FOBTs is £17, and the average amount of cash inserted into the machine is £55 per session, with one in five putting in over £100 a time.
- (4) On average, more than 80% of turnover in betting shops and more than half of profits are derived from FOBTs.

This Council believes that the increase in FOBTs is causing significant problems and believes that the Government should act to reduce the maximum stakes and slow down the speed of play. Council therefore requests the Leader to write to the Secretary of State for Culture, Media and Sport recommending a reduction in the maximum bet per spin on FOBTs to £2.
