## Cabinet Grants Decisions - 28 June 2021

### **Corporate Grant Schemes - Community And Economic Development Grants**

The Cabinet Grants Panel agreed:

- That a Community & Economic Development Grant of £20,000 be awarded Age UK West Sussex, Brighton & Hove to fund the support of the costs towards opening the Kings Weald Community Centre (Keymer Brick & Tile), Burgess Hill.
- 2. That a Community & Economic Development Grant of £2,700 be awarded to Burgess Hill Shed to fund the materials to set up a workshop for "The Kiln".
- 3. That a Community & Economic Development Grant of £5,000 be awarded to Carers Support West Sussex to fund their Check in and Chat befriending service.
- 4. That a Community & Economic Development Grant of £400 be awarded to Hassocks Baby Group to fund a volunteer run parent and baby group.
- 5. That a Community & Economic Development Grant of £3,157.60 be awarded to Sheddingdean Community Association to fund their annual rental cost of Sheddingdean Community Centre up to the end of their current lease.
- 6. That a Community & Economic Development Grant of £5,000 be awarded to Sussex Clubs for Young People to fund youth sessions at Court Bushes.
- 7. That a Community & Economic Development Grant of £537.95 be awarded to Windmills Opportunity Playgroup to their annual rental cost of Sheddingdean Community Centre up to the end of their current lease.
- 8. That a Community & Economic Development Grant of £4,999 be awarded to Albion in the Community to part fund Premier League Kicks project in Burgess Hill and Oathall.
- 9. That **no** Community & Economic Development Grant be awarded to Burgess Hill Town Council as their application has been referred to the Economic Development Team to be considered under the 'Welcome Back Fund' for high streets as the application seek to encourage gatherings in public spaces post Covid.



- 10. That **no** Community & Economic Development Grant be awarded to Hurst Festival as their application has been referred to the Economic Development Team to be considered under the 'Welcome Back Fund' for high streets as the application seek to encourage gatherings in public spaces post Covid.
- 11. That **no** Community & Economic Development Grant be awarded to Warninglid Primary Academy as their applications cannot be funded under the criteria that states, 'education activities will not be funded where central government, the health authority or county council are the most appropriate funder'.
- 12. That **no** Community & Economic Development Grant be awarded to Warden Primary Academy as their applications cannot be funded under the criteria that states, 'education activities will not be funded where central government, the health authority or county council are the most appropriate funder'.
- 13. That <u>no</u> Community & Economic Development Grant be awarded to Sussex Association of Spina Bifida & Hydrocephalus as the set-up costs to re-design the service was funded through a previous Covid-19 Recovery fund application and the criteria set in the Community Grants fund excludes funding for ongoing project costs.

## **Corporate Grant Schemes - Facility Grants / Release Of S106 Contributions**

The Cabinet Grants Panel agreed:

- 1. That £2,000 of S106 contributions be released to Scaynes Hill Millennium Village Centre to fund the upgrade of the existing air ventilation system with a purification unit to improve the facilities and encourage more users to take part in social and community activities in the centre in a Covid secure environment.
- 2. That £5,814 of S106 contributions be released to Ashengound Community Centre to fund the installation of LED lighting to improve energy efficiency and reduce overhead costs.
- 3. That £171,160 of S106 contributions be released to Sussex Clubs for Young People Ltd to fund the extension and refurbishment the pavilion at Barn Cottage Recreation Ground to make it suitable for a wider range of activities and community management.
- 4. That £100,000 of S106 contributions be released to Mid Sussex District Scout Council to fund the construction of a new community centre at Barn Cottage Recreation Ground for use by the Scouts and other groups.
- 5. That the existing grant agreement with the St Francis Social and Sports Club CIC is withdrawn and terminated, and a new agreement enter into with the trustees of the St Francis Sports and Social Club to provide a Facility Grant of £405,374 for Stage 1 swimming pool changing rooms and associated drainage, services and professional fees.
- 6. To provide authority for the Council to enter into a Grant Agreement with Lewes District Council for an award of £200,000 toward the St Francis Sports and Social Club Stage 1 project costs.
- 7. To allow an extension of time for the delivery of St Francis Sports and Social Club Stage 1 to 'delivery of the Project must commence by 1 December 2021 and be completed by October 2023'.

## **Information and News**

#### **COVID-19 News**

Covid levels in Mid Sussex have risen quickly in the last week to about 110 cases per 100,000 from the very low levels we had in the middle of May 2021. The increase case levels in Mid Sussex are concentrated in younger age groups and therefore hospitalisations and deaths locally are flat despite the higher case levels.

Covid rates have generally risen across West Sussex in the last week but with no areas having a rate higher than the increased England average of about 140 cases per 100,000. The average Covid rate in West Sussex is now slightly above the increased South East average of about 80 cases per 100,000. Case levels in England and the South East have generally continued to rise in the last week but East Sussex still has lower Covid levels than most areas. Case levels in the 60+ age group, who are likely to have been double vaccinated more than 3 weeks ago, have remained low.

In some areas of the country Covid rates are well above 150 cases per 100,000 with the Delta variant being dominant across all of England. Brighton and Hove now have a case level above 150 cases per 100,000 and is a South East Covid hotspot.

Extra efforts have been made to keep Covid levels down in these hotspot areas with surge testing and additional vaccinations for all adults.

The third stage of the roadmap started on Monday 17th May 2021 with gyms/leisure centres, hotels and guest houses fully reopening, limited indoor home mixing and overnight stays and indoor service in pubs and restaurants. A leaflet is attached below explaining the advice to be cautious about meetings in private homes. Lateral Flow Tests are being used to identify people who have Covid but have no symptoms to try to maintain the low Covid rates now found in much of England. These free tests are available from local collection areas that can be located online or by requesting a postal delivery. Additional indoor mixing over the past six weeks and the Delta variant have resulted in an increase in Covid levels generally in England from late May but with a much smaller increase in hospitalisations and deaths have remained flat.

About 63% of the adult population in England and in Mid Sussex are now double vaccinated and about 85% have received a first vaccination and all adults are now eligible to book a vaccination jab with the second vaccinations being done after 8 weeks. This vaccination programme is being relied on to keep hospitalisations and deaths down despite the rapid increase in Covid cases across much of England.

The roadmap envisaged most Covid restrictions being lifted from 21st June 2021 subject to the four data tests being met. Due to the rapid rise in cases and the greater dangers of the Delta variant most of the relaxations proposed for 21st June have been delayed for 4 weeks to 19th July 2021 to get more of the adult population double vaccinated. It is important people remember Hands Face Space and Fresh Air as more people are out and about and Covid rates have increased due to the more infectious Delta variant .

The continuing local Covid vaccination programme is central to keeping hospitalisations and Covid deaths down but indoor social mixing, the Delta variant and possible new variants of the Covid virus are likely to continue to push the Covid figures up in the next few weeks.

## Clair Hall Public Engagement And Consultation Programme Launched

- MSDC launches twelve-week engagement programme
- Haywards Heath-community encouraged to participate and help shape the future of the Clair Hall site

Mid Sussex District Council has today launched a public engagement and consultation programme on the future of the Clair Hall site in Haywards Heath.

Starting with 12 weeks of varied engagement activities over the course of the summer, the council will seek and listen to the views of the local community about what the Clair Hall site means to them and how they would like it to support and provide for the town in the future.

The engagement will begin with a series of both digital and physical events in July and over the course of the summer the Council will support an evolving and varied consultation programme to give the local community in Haywards Heath a wide range of opportunities to have its say on the future of the site. It is vitally important that the broadest cross-section of the local community has the opportunity to share their views. The engagement programme will include drop-in sessions, one-to-one meetings, webinars, and a whole host of measures to give everyone in the local community the opportunity to participate. The aim is to establish how the Council can breathe new life into this gateway site and make sure that it is able to meet the demands and expectations of the 21st Century once it is no longer required as a vaccination centre.

The Council is seeking feedback from a wide variety of stakeholders, including community groups, the town council, and the wider local community. Through this engagement and consultation programme, the Council wishes to fully understand local community use and future demand for services and activities in the town and how that could be accommodated.

At this stage, there has not been any decision made on the future, with the driving ambition of the engagement process to offer the local community the opportunity to inform and shape options and recommendations for this important site.

Cllr. Norman Webster, Cabinet Member for Community said, "I am delighted to see the commencement of this public engagement and consultation programme on the important issue of the future of the Clair Hall site. Over the coming months, through clear and transparent dialogue with a wide range of voices in Haywards Heath, and beyond, this Council wants to identify how the Clair Hall site can continue to contribute to the vibrancy of the local community, in a manner that is both sustainable and fit for the 21st century. I look forward to listening to the views of our local communities and working with them to shape the future of this site"
