SAFEGUARDING TRAINING



Date & time 13 February 2013 (18.30 – 20.30)

Venue Council Chamber

Introduction Safeguarding is about protecting children, young people and adults at

risk from harm. The training will cover what is meant by 'safeguarding' exploring the different categories of abuse and thinking about the different ways that abuse comes to light or is detected. The training will provide you with up to date information on the Council's policy and procedures for dealing with a concern you may have about a resident. You should attend this training because along with protecting the

vulnerable people we work with it is also about protecting the vulnerable people we work with it is also about protecting you. As a Councillor you are in a position of authority and trust and with many of you meeting local residents as part of your work you could be 'at risk' from allegations of abuse. The training will outline how to keep yourself safe from allegations of abuse and outline ways of doing this while still maintaining your accessibility to the local residents you

represent.

Target Audience All Members are advised to attend this training.

Learning Objectives

By the end of the workshop participants will have learnt:

- the District Council's responsibilities in relation to safeguarding children and adults at risk;
- what is meant by the terms "safeguarding" and "promoting the welfare" of children and adults at risk;
- different types of abuse;
- what to do if you have a concern;
- procedures relating to how concerns are reported and managed in the council and how to find your Designated Officer;
- Safer Working Practices- Keeping yourselves safe form allegations; and
- where to access further training or information.

Other Details

The safeguarding policy is in place to support staff and members as well as children, young people and adult at risk.

Safeguarding is relevant though all areas of the councils work from agreeing contracts through to licensing, environmental health, recruitment, community safety and many more. During the training what the council has in place to reach their obligations under Section 11 of the Children's Act 2004 will be outlined.

All members of staff have a Designated Safeguarding Officer so if you have any concerns about a child, young person or adult at risk then please contact them for advice and support. The procedures internally for dealing with any concern you have will be reviewed so

you are clear on who you would talk to and what the following procedures would be.

All organisations have a duty of care for the children for whom they provide activities or services. (2004 section 11 of the Children Act). Mid Sussex District Council is committed to practices that protect children from harm and treat them with respect. At the same time the Council will protect its staff from the risk of unfounded allegations.

REPORT FROM SPECIAL HEALTH PANEL MEETING - 8 JANUARY 2013

Attendance: Cllrs Belsey, Jones, Landriani, Moore, Snowling, Webster

A special meeting of the Health Panel was held on the evening of 8th January 2013 to which all Members of the Council had been invited. The purpose of the meeting was to enable Dr Minesh Patel, Chair of the Horsham and Mid Sussex Clinical Commissioning Group, to set out the Clinical Commissioning Group's plans for the year ahead and to take questions from Members regarding the forthcoming changes in the organisation of the NHS.

Dr Patel explained the changes that were taking place within the NHS, with Primary Care Trusts being replaced with Clinical Commissioning Groups (CCG) led by General Practitioners, and the Public Health function moving to County Councils. He explained that this change would take place from April 2013, but that a great deal of work has already been undertaken to prepare. Three Clinical Commissioning Groups will cover West Sussex - Coastal CCG, Crawley CCG and Horsham and Mid Sussex CCG. It was noted that the local CCG would be a small organisation with only around 50 employees.

He then presented the CCG's priorities and plans for this area in the coming years and heard questions and views from Members about this.

Dr Patel explained that the draft local priorities for the coming year had been developed with input from a range of local stakeholders over recent months and Members' views were sought. Local priorities

Frail elderly

- Pro-active care for people with long term conditions
- Dementia
- End of Life Care
- Stroke care

Cancer outcomes Mental Health Childrens' services

Prevention

- Strokes, heart attacks
- Alcohol, obesity, smoking

Dr Patel then went on to explain the CCG's commissioning plans for each of these priority areas in more detail and took questions from Members. Discussion covered the following areas:-

- Deficiencies in some aspects of children's community services, particularly children's mental health
- Importance of close working with WSCC and the Joint Commissioning Unit whose focus will continue to be on mental health, substance misuse, frail elderly and learning disabilities
- Importance of getting joined up ICT solutions in place for the efficient sharing and recall of data MSDC Member Information Service – 30th January 2013

- That preventative work has a key role to play and that the CCG will need to work in partnership with this Council's Health and Wellbeing service, social care, Prevention and Assessment Teams, the voluntary sector and carers' support organisations in this area.
- That 'supported self-care' would be an important model, particularly when working with people with long term conditions (such as diabetes, arthritis etc)
- That there are considerable challenges associated with the expanding population which will need to be addressed by the CCG in conjunction with the Surrey and Sussex NHS Commissioning Board which will be responsible for commissioning future GP services.
- That support for carers was crucial and that all GPs are encouraged to establish and maintain a carers' register.

BRIGHTON AND SUSSEX UNIVERSITY HOSPITALS NHS TRUST - NEW CHIEF EXECUTIVE

Following the departure of Duncan Selbie as Chief Executive last year, the post has been filled on an interim basis by Chris Adcock. However, it has recently been announced that Matthew Kershaw has now been appointed as the new Chief Executive. Representatives from the Council will be arranging to have an initial meeting with him in the near future.

HELPING ROUGH SLEEPERS

Following on from Councillor Snowling's reference at Council on 23rd January, this note is to advise Members of what help is available to rough sleepers, particularly in extreme weather conditions, and to provide you with contact details should you wish to report someone sleeping rough.

We are required by the DCLG to consult with stakeholders each year and provide the Government with an estimate of rough sleepers. This exercise has to be done for a particular night and was last carried out for the night of 22/11/12 and a figure of 6 was provided (as against 5 last year). We consulted, in writing, with 23 agencies including the Police who actually carried out a count for us and found 1 person that night. This is a modest number compared to many areas, but nevertheless it is important that we have help on hand for those affected, particularly in such cold weather.

All the agencies we consult with have been made aware of the help the Council's Housing Needs Team can give to rough sleepers, particularly in emergencies when the weather is expected to be below freezing on 3 consecutive nights. This help is set out on our website through a link on our www.midsussex.gov.uk/housingadvice page which takes you to www.midsussex.gov.uk/media/MSDC_leaflet_on_help_for_rough_sleepers_Sep12.pdf .

In extreme cases, where the weather is expected to be below freezing on 3 consecutive night, the Housing Needs Team will arrange B&B, or a place in a Direct Access hostel such as Crawley Open House, on a night by night basis using the discretionary powers contained in the legislation for non-priority homeless people (non-priority homeless people are generally single people or couples without children, whom we would not normally have a duty to rehouse if they became homeless). Although this is a power and not a duty, we will always find somewhere for non-priority rough sleepers in extreme weather. So far this winter, we have placed 2 single people into guest houses using these powers. We would then work with the rough sleeper to find a longer term solution - as we do with all homeless people.

We subscribe to a government funded service called Streetlink www.streetlink.org.uk where members of the public can report rough sleepers online which are then advised direct to the Housing Needs Team for assistance. The Streetlink link is on the www.midsussex.gov/housingadvice page of our website. Members can also contact Streetlink by telephone on 0300 500 914.

We are currently working with a Government funded initiative hosted by Eastbourne covering all 13 East & West Sussex Local Authorities which is called 'Sussex Homeless Outreach Reconnection Engagement' (SHORE) which

provides an outreach service to rough sleepers. The Housing Needs Team refer cases to this initiative and work closely with the outreach worker who covers Mid Sussex.
