Decisions made by the Cabinet Grants Panel

The following decisions have been made by the Cabinet Grants Panel and will come into effect at 10.00 a.m. on Thursday, 21st March 2013, unless the call-in procedure is activated. If you wish to request that a proposed decision is called in, please contact Jo Harper on 01444 477421 (jo.harper@midsussex.gov.uk) in addition to making a written request to the Monitoring Officer, Tom Clark.

That:

- (1) the suggested theme for the Spotlight Programme for 2013/14 entitled "Make a Difference in your Local Community" be supported;
- a grant of £45,000 (22.5% of the total project cost) be awarded to the East Grinstead Sports Club, to install a new water based hockey pitch, which is made up of £5,227 (P35/519), £33,995 (P35/518) and £5,778 (P35/518) Section 106 formal sports monies. This grant offer be made, subject to the following special conditions:
 - (a) it can be demonstrated that the project can be funded in its entirety within 12 months of the grant offer; and
 - (b) the project being completed within 12 months of project funding being obtained.
- (3) a grant of £2,041 (75% of the total project cost) be awarded to East Grinstead Cricket Club towards the purchase and installation of new cricket nets, which is made up of £2,041 (P35/518) Section 106 formal sports monies. This grant offer be made subject to the project being completed within 12 months of project funding being obtained;
- (4) a grant of £1,100 be awarded to Burgess Hill Youth towards a programme of school holiday activities, subject to further information being provided and the subsequent approval by the Chairman of the Panel, concerning the level of reserves held by the organisation;
- (5) a grant of £300 be awarded to Chestnut Tree House for materials for play therapy;
- (6) consideration of the grant application for the Hurstpierpoint Society's tree planting be deferred and the applicant be advised that the application will be considered as part of the Spotlight grant round in September 2013;
- (7) a grant of £2,000 be awarded to Kangaroos as a contribution towards PALS Saturday Club and Playscheme;
- (8) a grant of £750 be awarded to Sussex Association for Spina Bifida and Hydrocephalus (SASBAH) as a contribution towards the Advisor Service, Social Programme and Buddy Scheme;

- (9) a grant of £750 be awarded to Sussex Autism Support towards extending their book and resource library, purchase of advertising banner, laminator and trimmer;
- (10) a grant of £500 be awarded to Tadpoles Swimming Club for the Disabled as a contribution towards pool hire, training and training equipment maintenance;
- (11) a grant of £1,500 be awarded to Relate North and South West Sussex Relate Outpost East Grinstead.

COMMUNITY GOVERNANCE REVIEWS

The Council is currently undertaking community governance reviews in three parts of Mid Sussex and is seeking views on the proposals for changes to electoral wards. The terms of reference for the reviews have previously been agreed at Full Council.

The three community governance reviews and proposals are:

Burgess Hill Town Council

• The merger of the wards of Meeds North and Meeds South back into a single ward known as Meeds.

East Grinstead Town Council

- The movement of the Imberhorne/Baldwins ward boundary to bring it into line with the District Council boundary.
- The merger of the wards of Town North and Town South back into a single ward known as Town.

Hassocks Parish Council

- The merger of the wards of Keymer North, Keymer South and Stonepound into a single ward.
- The name of such a merged ward if created.

The Council is undertaking a twelve week public consultation exercise, running from 8th March 2013 to 31st May 2013. There is a Community Governance Reviews section of the Council's website http://www.midsussex.gov.uk/communitygovernancereviews that provides detailed information about the reviews and consultation arrangements.

The Parish and Town Councils involved have been contacted to formally submit their views on the proposals, as has West Sussex County Council.

Following the consultation exercise, proposals will be considered by the Council's Leader and Service Delivery Scrutiny Committee on 2nd July and then by Full Council on 24th July 2013. Any changes to be made to the electoral arrangements will come into effect at the next full elections of Parish and Town councillors in May 2015.
