WELLBEING COMMISSIONING

Mid Sussex District Council is inviting applications for four separate tenders:-

1) Family Alcohol Project

The Council is inviting applications from suitably qualified contractors for the provision of an accessible tier 2 family alcohol service which provides support in the community to young people and their families who are at risk of drinking to hazardous levels. The project will form an integral part of the local alcohol care pathway.

2) Older people Physical Activity Project

The Council is inviting applications from suitably qualified contractors for the provision of an accessible project promoting and providing physical activity sessions to inactive older people in Mid Sussex who are at risk of social exclusion.

3) Adult Weight Management Service

The Council is inviting applications from suitably qualified contractors for the provision of an adult weight management service. The contractor will be expected to design and deliver an accessible tier 2 lifestyle adult weight management service, which supports overweight and obese adults to lose weight and learn how to maintain a healthier weight, and that will form an integral part of the local weight management care pathway.

4) Wellbeing Coaches

The Council is inviting applications from suitably qualified contractors for the provision of an evidence based, accessible service for adults who require additional support to make positive changes to their

lifestyle. The service will focus on the risk factors for cardio vascular disease (obesity, smoking, physical activity and alcohol)

PUBLICATION OF THE PROPOSED SUBMISSION DISTRICT PLAN

The District Plan will then be submitted to government and any comments received will be considered alongside the District Plan at public examination, hopefully later this year.

TEMPORARY STOP NOTICES AND TRAVELLERS

Overleaf is a letter from Brandon Lewis MP making clear that the Council can now serve temporary stop notices where travellers go on their own land to create encampments without planning permission.

Where travellers break into third party land (frequently in the ownership of the District Council) other processes apply to get the unauthorised encampment removed. This is a more straightforward process.

The stop notice will request them to leave the site and if they fail to do so the Council can prosecute those in breach of the notice. The stop notice lasts 28 days from service.

As the attached letter implies it is unlikely that the stop notice in its self will result in compliance and the Council is likely to have to use the 28 day period to finalise an enforcement notice or where the environment is under serious threat from the encampment to seek an injunction from the court to get the site vacated.

Improving councils' ability to tackle unauthorised caravan sites

I continue to hear concerns about the abuse of the planning system by a small minority of travellers who fuel community tensions by choosing to ignore planning rules. We know that Bank Holidays often see an increase in unauthorised development when councils' offices are closed for a longer period than normal. Intentional unauthorised development undermines confidence in the planning system and we are determined to give local councils powers to stamp it out wherever possible.

So I am pleased to confirm today that we are lifting restrictions on the use of Temporary Stop Notices in relation to caravans which were introduced by the previous administration. The Town and Country Planning (Temporary Stop Notice) (Revocation) (England) Regulations 2013 will revoke regulations which limited where councils could use Temporary Stop Notices in relation to caravans on 4 May. This will give you more freedom, backed up by potentially heavy fines, to take immediate action to stop unauthorised caravans in their tracks. Taking swift and decisive action can prevent costly, long drawnout stalemates like Dale-Farm and safeguard valuable environments and landscapes, such as the Green Belt.

Councils will now be able to issue Temporary Stop Notices immediately where there is a suspected breach in planning control, allowing you time to consider whether further enforcement action is necessary.
