THINK FAMILY/EARLY INTERVENTION

The Portfolio Holder for Health and Community has asked for Members to be provided with an update on the work the Council is undertaking to support families in particular need in the District.

Members will recall that the Mid Sussex Partnership (MSP) set up an Early Intervention Project to work with families in the District who are starting to struggle to prevent worse family breakdown occurring. The Early Intervention Project worker, Sarah Farr, carries out intensive 1-1 work with families over a period of up to a year, helping them with issues such as parenting skills, setting boundaries, managing finances and addressing abusive relationships. The project has been running for just over 18 months and in that time has undertaken very intensive work with 16 families. Six of these families have successfully exited the service and 10 are still receiving interventions. Members will also be aware of the national roll-out of the Troubled Families Initiative. This has been taken on locally by West Sussex County Council and named 'Think Family Expansion'. As part of the Think Family Expansion, the Council has been commissioned to provide another keyworker who will work with families referred through the County-wide programme. To meet the threshold for this programme, families need to meet at least 2 out of the 3 following nationally set criteria:

- There is a child in the family who has been subject to permanent exclusion; three or more fixed school exclusions across the last three consecutive terms or is in a pupil referral unit because they have been excluded or is not on a school roll; and/or has had 15% or more unauthorised absences or more from school across the last three consecutive terms. Or, the school has significant concerns about the attendance of one or more children in the family
- One or more under 18 year olds in the household with a proven offence in the last 12 months; and/or
 one or more members of the family has an anti-social behaviour order, anti-social behaviour
 injunction, anti-social behaviour contract or where the family has been subject to a housing related
 anti-social behaviour intervention in the last 12 months
- There is an adult claiming unemployment benefit in the household

Sarah Jones has now joined the Performance and Partnerships Business Unit to take on the role of Think Family keyworker, and will work alongside Sarah Farr to continue to provide high quality support to families in the District. These roles are further complemented by a number of other projects which have been set up by WSCC to operate in the District, dealing with families who have more complex needs than our own service can accommodate.

The following list describes some of the types of support our service can give:

- parenting support, including working with parents and children both separately and together to address relationship and behavioural issues
- practical matters such as improving the physical environment of the home
- supporting and advising on a move to more suitable accommodation if required
- organising referrals to suitable support groups, and encouraging attendance at these
- working with schools to agree support plans on issues such as behaviour, attendance and improving social networks at school
- helping families manage financial difficulties, addressing debt and learning to manage finances sustainably
- providing 1:1 support on low-level mental health issues such as anxiety and stress and ensuring appropriate mental health services are provided in more serious cases
- helping young people address antisocial behaviour issues and understand impacts of their behaviour

Since joining the team in June, Sarah Jones has started work with 5 families on an intensive one-to-one basis.

MID SUSSEX TRANSPORT STUDY – STAGE 2 BRIEFING NOTE

The Stage 1 Transport Study was completed in early 2013. Its purpose was to assess the impact on the transport network of land uses proposed in the District Plan, using the County transport model. The following briefing note explains the findings of the draft Stage 2 report, which is due to be finalised shortly.

The purpose of Stage 2 is to make further refinements, based on the results of Stage 1, in order to get a definitive picture of the impact the District Plan will have on the transport network. The aim is to ensure that the District Plan can be delivered without adverse or unacceptable effects on the transport network; the two studies will provide the evidence for this.

The Stage 2 modelling has been refined as follows:

- Stage 1 was produced before Neighbourhood Plan numbers were submitted by Town and Parish Councils. Stage 2 now uses the most up-to-date figures so can more accurately determine where in the District growth will occur.
- Stage 2 now includes the 480 dwellings at Kings Way, Burgess Hill, as a commitment rather than a future allocation. It is therefore considered in the 'Reference (baseline)' case rather than the 'Development (District Plan proposals)' case.
- The list of 'Primary and Secondary Interventions' (mitigation schemes) has been refined. This takes into account any schemes that are now considered as commitments which weren't considered at Stage 1, as well as amending and adding mitigation measures based on further discussions with the Northern Arc consortium, for example. Some schemes have been amended/added based on the results of Stage 1 in order to mitigate some of the capacity issues that Stage 1 flagged up. All have been discussed and agreed with WSCC Highways and are included in the Infrastructure Delivery Plan (IDP).

Junction Modelling and Results - Part 1

The modelling looks at two scenarios –

- Reference Case (which is a 'do nothing' approach, i.e. includes committed development but no further allocations through District Plan or Neighbourhood Plans)
- Development Case (i.e. all commitments plus District Plan and Neighbourhood Plan proposals)

This is in order to distinguish between capacity issues that may exist already or are naturally getting worse, and those that could be caused by the District Plan/Neighbourhood Plans.

The following Junctions are modelled to be over capacity in 2031:

Junction Modelling and Results - Part 2

The second part of the modelling looks at how to remedy the Junctions that are over-capacity due to the District Plan/Neighbourhood Plans.

All of these schemes have been modelled and will resolve the capacity issues to below 100%.

Some schemes shift traffic elsewhere on the network, particularly at Ansty. It is suggested that the existing mini-roundabout is replaced by signals in order to reduce potential congestion here.

Further mitigation measures are suggested for the junctions that are over-capacity, but not due to the District Plan. The majority involve signals or increasing lane approaches to roundabouts and the majority can be resolved (some, such as Stonepound Crossroads, have very little scope for resolving congestion issues).

Links Over-Capacity

The following road links are modelled to be over capacity in 2031:

Again, further mitigation measures are proposed to remedy the link capacity issues arising from the District Plan and Neighbourhood Plan proposals.

This mitigation is felt to remedy the situation, and will not be a constraint on the District Plan being approved and implemented.

A23 Junctions

Modelling has suggested that there are no concerns surrounding links, junctions or bridges in terms of being over capacity aside from two:

A23/A2300 Hickstead – Existing mitigation should resolve any traffic issues arising from the District Plan proposals, however it will need to be enhanced by widening the A2300 to dual 2-lane carriageway between A23 and A273 to accommodate traffic demand.

A23 / M23 Pease Pottage – Problems will arise with and without the District Plan, and should not be a constraint on the District Plan being adopted. Resolving these issues should not be a condition for approval of the District Plan.

Ashdown Forest

A number of links and junctions through the Ashdown Forest have been measured. Although there would be small increases in traffic, all increases are considerably less than the threshold of 1,000 vehicles Annual Average Daily Traffic. The District Plan therefore does not cause traffic flows that would impact greatly on the Ashdown Forest.

Conclusions

The junction and link capacity issues that are modelled to arise in 2031 as a result of the District Plan can be remedied by the schemes suggested in the report. These are currently being verified by WSCC Highways as being feasible (in design/land terms).

The study concludes that the District Plan could be successfully delivered in transport impact terms (i.e. would pass the NPPF transport requirement) provided that the schemes suggested are factored in.
