## DISTRICT PLAN EXAMINATION – EXPLORATORY MEETING, 16th SEPTEMBER

Following submission of the Mid Sussex District Plan to the Planning Inspectorate at the end of July, an Inspector has been appointed – Mr David Hogger.

Mr Hogger has been looking at the Plan and supporting documents over the last few weeks, and has requested an 'Exploratory Meeting' into whether the Council has met the legal 'Duty to Co-operate' test. He needs to establish this before continuing with the main part of the examination.

The Exploratory Meeting will be a meeting in public on the 16th September, at 2 p.m. in the Council Chamber. However, only those who the Inspector has invited will participate in the discussion. This will be lead officers from Mid Sussex, Crawley, Horsham, Brighton & Hove, Lewes, Adur & Worthing, Arun and Chichester Councils and the South Downs National Park Authority.
