This Workshop relates to the progression of the Mid Sussex District Plan **and all Members of the Council are invited to attend this meeting.**

It is intended to take a proposed submission version of the District Plan to the next meeting of the Scrutiny Committee for Planning and Economic Development on 3 March and then to a Special Meeting of full Council on 18 March (ahead of purdah). Following the elections, the Plan will be formally published for six weeks and submitted for Examination.

The main element missing from the consultation document was the Council's proposed housing number. This will need to be included in the proposed submission version and officers have now completed the technical work on the need for and supply of housing in Mid Sussex. Officers would like to take the opportunity to explain their work ahead of the Scrutiny Committee on 3 March, together with any changes to the draft Plan.
