Adjustment of Local Land Charges Official Search Fee

The Cabinet Member for Planning agreed that the Building Control Enquiry 1.1 fee be increased from £6 to £8.50 and the Environmental Health enquiry 3.7 and 3.13 is reduced from £5 to £2.50.

Release of Section 106 Contribution to Extend Heritage Street Lighting Program

The Cabinet Member for Planning authorised the release of £9,637 to Cuckfield Parish Council from the Local Community Infrastructure.

Licence to Alter and Supplemental Lease to Construct a Fence in the Car Park and a Pedestrian Path at the Bolnore Recreation Ground

The Cabinet Member for Leisure and Sustainability and the Cabinet Member for Economic Development and Property authorised the Solicitor to the Council to:-

- (1) grant a supplemental lease of the land coloured in green on the plan annexed to the report to Bolnore Village Community Partnership for the residue of the term of the Lease, dated 12 September 2014 and made between (1) the Council and (2) Bolnore Village Community Partnership ("the Lease"); and
- (2) subject to completion of the supplemental lease, issue a Licence to alter the premises demised by the Lease and the Supplemental Lease; to enable the Bolnore Village Community Partnership to construct safety fencing in the car park and a pedestrian path at the entrance.
