Rampion Offshore Windfarm, Twineham

The Rampion Offshore Windfarm has just been given the greenlight to begin development having secured £1.3 billion from E.ON and the Green Investment Bank.

This 400MW windfarm (13km off the Sussex Coast) will consist of 116 turbines and generate enough electricity to supply 300,000 homes over the 25 year lifetime of the project.

Construction work will begin on Stage 1 in June 2015 at the onshore substation site in Twineham and continue through 12 onshore stages. It is envisaged that between 350 and 450 jobs will be provided during these stages. Offshore construction will begin early 2016 with completion of the windfarm likely in 2018.

Please find attached an Information Sheet outlining the construction timescales.

Information for the community


We've produced this leaflet to make sure you have the information you need about our construction works, and how to get in touch with us if you have any questions or concerns.

Whether you live, work or travel in the development area, we'll keep you up to date with our plans throughout Rampion's construction. We'll also carry out work in a way that's sensitive to the needs of local communities, including:

- telling you where and when to expect construction works and what we're doing
- explaining any potential effects of construction and how we'll minimise the impact
- making it easy for you to get in touch with us, if you want to know more or have a complaint.

Onshore construction is planned to start from June 2015, over a period of two years. Most of the civil construction works that involve earth moving and lorry movements should be completed in the first year, with most of the second year set aside for electrical assembly and commissioning.

The offshore construction is scheduled to start in early 2016 for around two and a half years, so the wind farm will be completed and operating in 2018. The onshore works take place first so that when the first offshore turbine is installed, it can be connected to the national grid to generate electricity and allow for testing.





Construction in your local area

In order to provide a more tailored approach to our communications we've broken the onshore project down into 12 stages of construction:

Stage 1: Bolney substation crossings

Stage 2: Bob Lane and Herring Stream

Stage 3: Woodmancote, B2116 and A281

Stage 4: Three stream crossings and Horn Lane

Stage 5: Edburton Road

Stage 6: Tottington Mount and South Downs Way

Stage 7: Beeding Hill

Stage 8: Coombes Road and River Adur

Horizontal Directional Drilling (HDD)

Stage 9: Five Ways Public Rights of Way (PRoW)

Crossing and Titch Hill

Stage 10: Lamleys Lane and A27 HDD exit pit

Stage 11: Upper Brighton Road to north of railway

Stage 12: North of railway to Brooklands

The onshore construction will start with the onshore substation (stage 1), followed soon after by the cable route trenching works. The cable route construction will start in the south at stage 12 and generally work northwards to stage 2, although weather and logistics may mean some changes in the order of construction. Prior to the start of works for each of these stages of construction, we'll write to those homes and businesses near to construction activities, to inform them of our construction plans.

This will include:

- a brief description of works
- the date the works are due to start and how long they'll last
- the lead contractor's details
- how you will be able to contact us for more information.

We'll be working with the local media, including local papers, to keep you up to date with our construction news.

Partner websites

We're working with our partners to make sure as many people as possible know about our construction plans. West Sussex County Council and South Downs National Park Authority will have information on their websites and we've asked parish councils and other interest groups along the cable route to share our construction news with their communities.



Special interest user groups

We know some of you may have a particular business or recreational interest in the areas we'll be using during construction. Here's some more information you may find useful.

Archaeological interests

We carried out onshore surveys along the cable route in 2013, which included archaeological trial pits to identify any areas of archaeological sensitivity we may find during construction.

The county archaeologist will be on-site to monitor construction works in areas of sensitivity and identify any archaeological finds.

We'll use approved tailored construction methods in these areas, to increase the possibility of identifying, preserving or retrieving archaeological remains.

We're planning to hold an archaeological dig for local enthusiasts and groups at Tottington Mount, the site of a scheduled cross dyke monument. The event will include a talk on the history of the area and our special construction techniques. Please get in touch if you'd like to find out more (date to be confirmed).

Public Rights of Way (PRoW) users

There are a number of PRoWs along the cable route, including the popular South Downs Way National Trail and many others in the South Downs National Park and on the Weald. We'll do our best to keep PRoWs open during construction, but from time to time we may need to close or divert them temporarily.

We held a workshop for PRoW user groups in October 2014 and have set up a dedicated PRoW Project Liaison Group, who will meet quarterly throughout the two year onshore construction period. The workshop helped identify the most important PRoWs for walkers, cyclists and horse riders, as well as key junctions and roads linking them together. User groups also told us about important events and times of the year, and we'll aim to avoid them wherever we can.

Finally, we discussed the best way to communicate with PRoW users, to keep them up to date with construction news and minimise any inconvenience. As a result, we'll be putting signs up at key car parks and PRoW junctions, and we've asked those involved to share information through their websites and newsletters, including West Sussex County Council, South Downs National Park Authority, parish councils and PRoW user groups.

Divers and recreational sea users

For most of the three year offshore construction period, relatively small areas of the offshore wind farm site will be constructed at any one time. There will be a 500 metre (m) safety zone around each area, to protect sea users. Throughout construction, we'll update sea users regularly, so you know what, where and when works will be going on. We'll also appoint a Diving Liaison Officer who will work closely with the diving community.

Commercial fishing

We've been working closely with the local fishing industry since 2011, to minimise the impact of the wind farm and make sure we can work sustainably side by side. As a result, we've produced an overarching Coexistence Plan, setting out how we'll work together and manage safety, communication, mitigation and compensation. There are two Rampion working groups representing commercial fishing interests and they'll continue to meet regularly during construction.
