#### The Introduction of Special Parking Tariffs During December 2015

The Cabinet Member agreed that:-

- (1) a special flat rate tariff of £1 be introduced in specific long-stay car parks on Saturday, 5<sup>th</sup>, 12<sup>th</sup> and 19<sup>th</sup> December 2015; and
- (2) free parking be offered after 1.00 p.m. in short-stay car parks on one day in each town, to coincide with a Christmas activity e.g. turning on of Xmas lights, late night shopping etc.
