The Horsham and Mid Sussex Clinical Commissioning Group (CCG) has recently published an update on services.

Community Urology

The new community urology service, which aims to provide shorter pathways and quicker waiting times was launched on 1st October 2015.

The service will see the following conditions: Male Lower Urinary Tract symptoms; Chronic male pelvic pain (including chronic scrotal and prostatitis); Female urinary incontinence; Erectile dysfunction; Recurrent urinary tract infections and Catheter related problems

The service will be provided by 2 accredited providers, the Queen Victoria Hospital NHS Foundation Trust and Sussex Medical Chambers . The service will be available within a variety of locations throughout Crawley, Horsham and Mid Sussex. GPs are required to give patients a choice of provider.

Audiology

Both Crawley & Horsham and Mid Sussex CCGs now have four audiology providers all of whom are accredited to the national quality standards.

There are very few number of CCGs nationally who have all their providers with this accreditation which ensures a high quality of care.
