Proposed Lease Renewal – Unit 29, Orchards Shopping Centre, Haywards Heath (EXEMPT)

The Deputy Leader:

Armed Forces Awareness Training

Mid Sussex has a large Armed Forces Community – 31,863 Veterans in West Sussex, with 4,673 Veterans in Mid Sussex (2021 Census Figures).

If you work with residents, you are likely to meet members of this community, but do you fully understand how best to support them?

The Armed Forces Covenant has now been enshrined in law, meaning there is a legal requirement for local authorities to ensure 'due regard' in the provision of services for this community in certain key areas.

This relaxed and informative training is designed to support this change through increasing and/or refreshing your understanding of:

- Who are the Armed Forces Community?
- What challenges are they likely to face?

Bring Photo ID to vote, from May 2023

The Elections Act 2022 introduced a requirement for voters to show photo ID when voting at a polling station at some elections. This new requirement will apply for the first time in England at the local government elections on Thursday 4 May 2023. Even those already registered to vote in Mid Sussex and who receive a poll card, must still bring photo ID to vote at a polling station.

Which forms of photo ID can electors use to vote?

Many voters will have a form of photo ID that is acceptable. They can use any of the following:

- Passport
- Driving licence (including provisional license)
- Blue badge (issued to disabled / chronically sick persons)
- Older Person's Bus Pass, Disabled Person's Bus pass
- Oyster 60+ Card
- Freedom Pass
- Identity card with PASS mark (Proof of Age Standards Scheme)
- Biometric Immigration document
- Ministry of Defence identity card
- National identity card issued by an EEA state

For those who don't have an accepted form of photo ID

Voters who don't already have an accepted form of photo ID, or who are not sure that the photo ID still looks like them, can apply for a free voter ID document, known as a **Voter Authority Certificate**. Applications are made via: woter-authority-certificate.service.gov.uk. Alternatively, they can complete a paper application form and send this to the electoral services team here at Mid Sussex District Council.

The Electoral Commission (EC) Launches Public Awareness Campaign

The EC's public awareness campaign launched in England on Monday (9 January). The campaign concept, 'Note to self', aims to raise awareness of the new requirement. 'Note to self' features giant handwritten sticky notes as unmissable reminders that will prompt voters to bring their ID on polling day. Voters can expect to see the sticky note reminders across advertising channels including billboards and buses, online in their social feeds, on website banners and in local newspapers. The Commission's TV advert will appear on linear TV and 'Video on Demand' and will be used across a range of digital channels to increase the shareability of the campaign. Campaign adverts will direct voters to the EC's website to find out more information.



The Council is complimenting the national campaign with our own messaging on social media, via the print media, through stakeholders and partner communications, on our refuse trucks and much more. How to apply for a Voter Authority Certificate

On 16 January, the Department for Levelling Up, Housing and Communities published information on how to apply for a photo ID to vote (called a 'Voter Authority Certificate').

Individuals will be able to use the Voter Authority Certificate to vote in person in some UK elections and referendums, however, it cannot be used as proof of identification for any other reason. Individuals only need to apply for a Voter Authority Certificate if:

- they do not have accepted photo ID
- they no longer look like the photo on their ID
- the name on their photo ID is different to their name on the electoral register

DLUHC has also published forms to apply for a Voter Authority Certificate by post and for individuals who are living abroad, in the armed forces, a Crown Servant or a British Council employee.

Councils are encouraged to share this information as appropriate.

COVID-19 News

Covid is now endemic, and we are working to live with it. Covid rates in West Sussex and across the UK had gradually risen during the festive period however now shows signs of falling. The West Sussex rate now averages about 85.3 cases per 100,000.

The best way to avoid serious illness from a Covid infection is to maintain the benefits of vaccination. Everyone aged 5 and over is eligible for a Covid vaccination. Booster vaccinations are available for all those aged 50 years plus or otherwise vulnerable. These booster vaccinations are now being carried out at Clair Hall and across West Sussex. They can be booked online or at some places a walk-in service is available.

Flu vaccinations are also well underway with walk-ins at many pharmacies.
