### Long-term plan for housing announced

Today (24 July), as part of a long-term plan for housing, the Prime Minister and the Secretary of State for Levelling Up, Housing & Communities, Rt Hon Michael Gove MP, outlined plans to supply homes in places with high-growth potential in partnership with local communities. The Prime Minister also a confirmed today that the government will commit to building 1 million homes over this Parliament.

£800 million will also be allocated today from the £1.5 billion Brownfield, Infrastructure and Land fund to unlock up to 56,000 new homes on brownfield sites. The government is also providing £550 million funding for Homes England, which with income generated will mean a total investment of £1 billion.

There will also be additional reforms to the planning system, with a new fund of £24 million to scale up local planning capacity, and an additional £13.5 million to stand up a new team of experts to support large scale development projects.

### UKHSA launches new strategy to tackle national and global health hazards

The UK Health Security Agency (UKHSA) has today (25 July) <u>launched its three-year strategy to</u> combat both new and re-emerging threats and to protect health security.

The <u>new strategy sets out UKHSA's vision and goals for the next three years to prepare for and respond</u> to health threats and build the capabilities and technologies to protect the country in the future.

UKHSA works to protect the public against a wide range of health threats. These include infectious disease, chemical, radiation and nuclear hazards, extreme weather events and other environmental risks.

The six strategic priorities for UKHSA laid out in the strategy are to:

- Be ready to respond to all hazards to health
- Improve health outcomes through vaccines
- Reduce the impact of infectious diseases and antimicrobial resistance
- Protect health from threats in the environment
- Improve action on health security through data and insight
- Develop UKHSA as a high-performing agency

### Social Housing Act receives Royal Assent to become law

<u>DLUHC announced that reforms to social housing have now become law as the government's new Social Housing (Regulation) Act received Royal Assent</u> (20 July).

This means working towards changes in holding landlords to account, placing the needs of tenants at the centre of government reforms to improve the quality of life for those living in social housing across the country.

The law brings forward the following changes:

- Strengthening the Regulator of Social Housing to carry out regular inspections of the largest social housing providers and the power to issue unlimited fines to rogue social landlords
- Additional Housing Ombudsman powers to publish best practice guidance to landlords following investigations into tenant complaints
- Powers to set strict time limits for social landlords to address hazards such as damp and mould
- New qualification requirements for social housing managers
- Introducing stronger economic powers to follow inappropriate money transactions outside of the sector
