### Planning Guidance: Letter to Chief Panning Officers about Biodiversity Net Gain

On 6 October, DLUHC issued a letter to chief planning officers of local planning authorities in England with details of the latest announcements from DLUHC and other government departments and agencies relating to planning practice and policy.

The letter highlights the Department for Environment, Food & Rural Affairs' announcement on 27 September about the next steps and the updated timetable for Biodiversity Net Gain (BNG).

It also confirms that the government will publish all guidance and the regulations by the end of November, to help the sector prepare for the implementation of BNG.

# Personal safety for Councillors webinar

As part of the Local Government Association's (LGA's) Civility in Public Life Programme, they are hosting a series of webinars on councillor personal safety and handling online abuse and intimidation. The first programme has been devised for councillors who want to improve their awareness of personal safety.

<u>The LGA is hosting a webinar on Thursday 12 October at 2:00 – 3:30pm.</u> Built around the role of the elected member, the session will provide attendees with an awareness of the steps that can be taken to manage trolls and cyber-bullies, including a gentle introduction to the legal framework around social media posts. There will be guidance on how to be safe online generally, as well as tips on how to create a positive online presence.
