#### **Elector Absent Vote Changes**

From Tuesday 31<sup>st</sup> October 2023, the way in which electors apply for a postal or proxy vote is changing. These changes are as a result of the Elections Act 2022 and introduces the ability for electors to apply for an absent vote online. In addition, applications will need to include the applicant's National Insurance Number so that their identity can be verified.
