### **Changes to various permitted development rights: consultation DLUHC Consultation**

This is a technical response to the Government's consultation on proposed changes to permitted development rights. These are developments that might be carried out without the need for a planning application.

The proposals include revisions to permitted house extensions, upwards extension of a range of buildings, demolition of buildings and rebuild as homes, electrical outlets for recharging electric vehicles and air source heat pumps.
