#### Disposal of Surplus Council Land at Imberhorne Lane Car Park (EXEMPT REPORT)

The Cabinet Member for Economic Growth approved the name of the entity from 'Bidder A' to a special company that 'Bidder A-1' will contract to buy land at Imberhorne Lane Car Park, East Grinstead.

## Lease Renewals at the Orchards Shopping Centre, Haywards Heath (Units C and Unit 12) (EXEMPT REPORT)

The Cabinet Member for Economic Growth authorised the grant of a new FRI lease to Monsoon Accessorize Limited at Unit 12 for a term of 5 years, authorised the grant of a new FRI lease to Mountain Warehouse Limited at Unit C for a term of 5 years and authorised the Solicitor to the Council to conclude the aforementioned transactions on the terms outlined in the report, and on any such other terms and conditions as the Solicitor to the Council may recommend to protect the Council's position.

## Empty Homes Council Tax Premium

The Cabinet Member for Finance and Performance authorised the Council to maximise the increased premiums payable for long term empty properties covering three proposed changes to Council Tax discounts for 2019/20, 2020/21 and 2021/2022.
