Release of S.106 Funds & General Reserves for Refurbishment of Sheddingdean Community Centre

The Deputy Leader authorised the approval of funding for the Refurbishment Works to Sheddingdean Community Centre. A recent survey identified that the building required a new disabled access ramp and external works to ensure the building is water tight.


