

Member Briefing - Sites DPD - Monday 2nd September

Over the last year Officers, supported by a Member Working Group, have been working on preparation of the Site Allocations Development Plan Document (DPD), which will:

- i. allocate sufficient housing sites to address the residual necessary to meet the identified housing requirement for the District up to 2031 in accordance with the Spatial Strategy and Strategic Policies set out in the District Plan;
- ii. allocate sufficient employment land to meet the residual need and in line with the requirements of the District Plan;
- iii. allocate a site for a Science and Technology Park west of Burgess Hill; and
- iv. set out Strategic Policies necessary to complement those set out in the District Plan to deliver sustainable development.

Consultation is proposed to commence in October, following consideration of the Sites DPD at the Scrutiny Committee for Housing, Planning and Economic Growth meeting on Wednesday 11th September and at Full Council on Wednesday 25th September.

Ahead of the Scrutiny meeting, all Members are invited to a briefing on the Sites DPD and its proposals, at:

5:30pm on Monday 2nd September – in the Council Chamber

This briefing will be an opportunity for all District Councillors to understand the role and purpose of the Sites DPD, the technical work undertaken to support its development, and to understand the next steps in its preparation. I do hope you can attend.
