Mid Sussex Covid Guidance - Tier 2 from Wed 2 December 2020

From 0:01 hours on Wed 2nd December Mid Sussex along with the rest of West Sussex moved to Tier 2 of the Government's levels. Covid rates in Mid Sussex have been well above the West Sussex average for the past month. They have fallen from their Mid- November peak but are still above 50 cases per 100,000 population in all age brackets. The Tier 2 restrictions are unlikely to keep the virus rates falling and therefore it is important residents are cautious and stick to the restrictions below to avoid our Covid numbers rising rapidly at they did in October 2020 under the previous Tier 1 restrictions. When heading back to all the local shops residents would be wise to go at less busy times.

Please be aware of, and communicate with residents, the elements of Tier 2, including -

- you must not socialise with anyone you do not live with or who is not in your support bubble in any indoor setting, whether at home or in a public place
- you must not socialise in a group of more than 6 people outside, including in a garden or a public space – this is called the 'rule of 6'
- businesses and venues can continue to operate, in a COVID-Secure manner, other than those which remain closed by law, such as nightclubs
- pubs and bars must close, unless operating as restaurants. Hospitality venues can only serve alcohol with substantial meals
- hospitality businesses selling food or drink for consumption on their premises are required to:
 - provide table service only, in premises which sell alcohol
 - close between 11pm and 5am (hospitality venues in airports, ports, transport services and motorway service areas are exempt)
 - stop taking orders after 10pm
- hospitality businesses and venues selling food and drink for consumption off the premises can continue to do so after 10pm as long as this is through delivery service, click-and-collect or drive-through
- early closure (11pm) applies to casinos, cinemas, theatres, museums, bowling alleys, amusement arcades, funfairs, theme parks, adventure parks and activities, and bingo halls. Cinemas, theatres and concert halls can stay open beyond 11pm in order to conclude performances that start before 10pm
- public attendance at outdoor and indoor events (performances and shows) is permitted, limited to whichever is lower: 50% capacity, or either 2,000 people outdoors or 1,000 people indoors
- public attendance at spectator sport and business events can resume inside and outside, subject to social contact rules and limited to whichever is lower: 50% capacity, or either 2,000 people outdoors or 1,000 people indoors
- places of worship remain open but you must not socialise with people from outside of your household or support bubble while you are indoors there, unless a legal exemption applies
- weddings and funerals can go ahead with restrictions on numbers of attendees 15 people can attend wedding ceremonies and receptions, 30 people can attend funeral ceremonies, and 15 people can attend linked commemorative events such as wakes or stone settings.
- organised outdoor sport, and physical activity and exercise classes can continue
- organised indoor sport, physical activity and exercise classes will only be permitted if it is
 possible for people to avoid mixing with people they do not live with (or share a support bubble



- with). There are exceptions for indoor disability sport, sport for educational purposes and supervised sport and physical activity for under-18s, which can take place with larger groups mixing
- you can continue to travel to venues or amenities which are open, but should aim to reduce the number of journeys you make where possible
- if you live in a tier 2 area, you must continue to follow tier 2 rules when you travel to a tier 1 area. Avoid travel to or overnight stays in tier 3 areas other than where necessary, such as for work, education, youth services, to receive medical treatment, or because of caring responsibilities. You can travel through a tier 3 area as a part of a longer journey

Census 2021 will provide a snapshot of modern society

Households across Mid Sussex will soon be asked to take part in Census 2021. The official Census day will be on March 21. It will be the first run predominantly online, with households receiving a letter with a unique access code, allowing them to complete the questionnaire on their computers, phones or tablets from early March

The census will include questions about sex, age, work, health, education, household size and ethnicity. And, for the first time, there will be a question asking people whether they have served in the armed forces, as well as voluntary questions for those aged 16 and over on sexual orientation and gender identity.

A successful census is critical to ensuring our communities receive the funding and support that they deserve over the next decade. Nationally, councils play an important role in supporting the delivery of the Census with essential local knowledge. Members will be pleased to know that MSDC officers are already working with the local Census Engagement Manager, appointed by the Office for National Statistics, covering Mid Sussex, Horsham and Crawley.

As part of the wider community engagement exercise that the Council is providing support for, the Census Engagement Manager will shortly be contacting members directly to provide background information to help you understand the Census process in more detail and allow you to better direct constituent enquiries that you may receive in March. Please look out for the communication.
