Mid Sussex Covid Guidance - Tier 2 from Wed 2 December 2020

The latest public data for Covid rates in West Sussex can be found here.

You will see the number of cases per 100.000 was still well above 50 in Mid Sussex at the end of November. A particular high rate had been detected in East Grinstead schools with rates rising in East Sussex where it borders Kent, now a Tier 3 area. There was particular messaging to East Grinstead over last weekend for people to be additionally cautious when going about their business.

The latest provisional data is indicating a levelling off of cases in most of West Sussex but with a rise in Horsham DC to reach levels similar to those in Mid Sussex DC.



Level 2 Tier is designed to keep the rate of infection level, but this does depend on everyone complying with the letter and spirit of the restrictions.

Parts of Surrey and London are at higher and rising rates per 100,000 and similar to those found now in much of Kent.

West Sussex remains below the SE average, but that average is rising quite quickly. There is a review of the Tiers on 16th December but that is not likely to result in places in the SE moving to Tier 1 but with the possibility that London may need to go to Tier 3.

With vaccinations starting this week it is still important we all remember Hands Face and Space as we move around with caution over the Winter when hospitals are very busy in any year.

The specific Tier 2 regulations are explained below:

- you must not socialise with anyone you do not live with or who is not in your support bubble in any indoor setting, whether at home or in a public place
- you must not socialise in a group of more than 6 people outside, including in a garden or a public space – this is called the 'rule of 6'
- businesses and venues can continue to operate, in a COVID-Secure manner, other than those which remain closed by law, such as nightclubs
- pubs and bars must close, unless operating as restaurants. Hospitality venues can only serve alcohol with substantial meals
- hospitality businesses selling food or drink for consumption on their premises are required to:
 - provide table service only, in premises which sell alcohol
 - close between 11pm and 5am (hospitality venues in airports, ports, transport services and motorway service areas are exempt)
 - stop taking orders after 10pm
- hospitality businesses and venues selling food and drink for consumption off the premises can continue to do so after 10pm as long as this is through delivery service, click-and-collect or drive-through
- early closure (11pm) applies to casinos, cinemas, theatres, museums, bowling alleys, amusement arcades, funfairs, theme parks, adventure parks and activities, and bingo halls.
 Cinemas, theatres and concert halls can stay open beyond 11pm in order to conclude performances that start before 10pm
- public attendance at outdoor and indoor events (performances and shows) is permitted, limited to whichever is lower: 50% capacity, or either 2,000 people outdoors or 1,000 people indoors
- public attendance at spectator sport and business events can resume inside and outside, subject to social contact rules and limited to whichever is lower: 50% capacity, or either 2,000 people outdoors or 1,000 people indoors
- places of worship remain open but you must not socialise with people from outside of your household or support bubble while you are indoors there, unless a legal exemption applies
- weddings and funerals can go ahead with restrictions on numbers of attendees 15 people can attend wedding ceremonies and receptions, 30 people can attend funeral ceremonies, and 15 people can attend linked commemorative events such as wakes or stone settings.
- organised outdoor sport, and physical activity and exercise classes can continue
- organised indoor sport, physical activity and exercise classes will only be permitted if it is
 possible for people to avoid mixing with people they do not live with (or share a support bubble
 with). There are exceptions for indoor disability sport, sport for educational purposes and
 supervised sport and physical activity for under-18s, which can take place with larger groups
 mixing



- you can continue to travel to venues or amenities which are open, but should aim to reduce the number of journeys you make where possible
- if you live in a tier 2 area, you must continue to follow tier 2 rules when you travel to a tier 1
 area. Avoid travel to or overnight stays in tier 3 areas other than where necessary, such as for
 work, education, youth services, to receive medical treatment, or because of caring
 responsibilities. You can travel through a tier 3 area as a part of a longer journey

Economic Recovery Plan

The Covid 19 pandemic has had a significant impact. Throughout the pandemic the Council has rolled out immediate support and advice to businesses and residents including: issuing over £26.4 million in business grants to nearly 2,065 businesses and organisations, regularly liaising with businesses including the three Business Associations and the Chamber of Commerce; delivering a package of measures to ensure the re-opening of our High Streets safely; providing advice and assistance to food businesses, pubs, restaurants, social clubs and other licenced premises to open safely; and supporting the development industry (a key employment sector and provider of new homes including affordable homes) to continue to operate in a Covid-19 secure way.

In September 2020, the Council agreed to prepare an interim Economic Recovery Plan to highlight the Council's response to supporting Covid recovery for the remainder of this financial year. This includes a Covid 19 Recovery Grant which offers £300k to provide grants support to communities and businesses support.

The Economic Recovery Plan builds on the Government's pillars to support economic recovery: Backing Business, Increasing Opportunities, Securing High Value Inward Investment, Accelerating Innovation, and, Encouraging a Green Recovery.

Recognising the long term implications of Covid 19 the Council also agreed that in the next financial year it will agree a new Sustainable Economic Strategy fit to support Covid recovery. The Economic Recovery Plan is attached to this email.
