6. MINUTES

RESOLVED

7. DECLARATIONS OF INTEREST

The Chairman declared a personal interest in Item 4, St John's Park Charitable Trust, Burgess Hill - Proposed New Practice Net Facility and Lease Disposal, as his Grandson played for Burgess Hill Cricket Club.

8. RICHARD WORSLEY RECREATION GROUND CHARITABLE TRUST, CUCKFIELD - PROPOSED LEASE DISPOSALS

The Chairman introduced the report and invited Trustees to speak.

The two Cuckfield Members expressed their satisfaction with the report and that it represented good governance by the Trustees and a sound financial base on which to go forward. They asked other Trustees to support the report's recommendations.

9. ST JOHN'S PARK CHARITABLE TRUST, BURGESS HILL - PROPOSED NEW PRACTICE NET FACILITY AND LEASE DISPOSAL

Councillor Moore introduced the report and outlined the undertakings made by Burgess Hill Cricket Club. She acknowledged the need to replace the existing practice nets as well as the need to ensure replacements nets were secured against damage whilst ensuring community access to the area. She asked Trustees to support the report's recommendations.

Other Trustees welcomed initiatives to promote health and wellbeing in Mid Sussex, and to improve existing sporting facilities.

Responding to a Trustee's question, Tom Clark, Solicitor to the Charity Trustees confirmed that the designation of the land on which the practice nets stood would not be affected.

- (4) the Charity Trustees' Solicitor be authorised to obtain a report and recommendation on the main terms of the lease from an independent surveyor, in accordance with Section 119 of the Charities Act 2011 and report back to the Charity Trustees, as to the public response to the proposal and the main terms of the lease.
