# Minutes of a Meeting of the Mid Sussex District Council Cabinet Grants Panel held on Monday 10 December 2018 From 1.00 p.m. to 2.00 p.m.

#### 1. SUBSTITUTES

None.

#### 2. APOLOGIES

None.

#### 3. DECLARATIONS OF INTERESTS

Councillor Marsh declared a personal interest in the application from East Grinstead Sports Club as he taught the son of Gary Needle, Chairman of East Grinstead Sports Club, how to drive. He came to the meeting with an open mind to consider the comments of the Panel, officers and the applicants.

Councillor Webster declared a personal interest in the application from East Grinstead Sports Club as knows Gary Needle, the Chairman of the Sport Club, through his work as a non-executive director at the Queen Victoria Hospital which works closely with whoever holds the position of Cabinet Member for Community. He came to the meeting with an open mind to consider the comments of the Panel, officers and the applicants.

#### 4. MINUTES

The Minutes of the meeting of the Panel held on 16 October 2018 was approved as a correct record and signed by the Chairman.

#### 5. URGENT BUSINESS

None.

# 6. REPRESENTATIONS FROM MEMBERS OF THE COUNCIL

None.

#### 7. CORPORATE GRANT SCHEMES.

Elaine Clarke, Community Leisure Officer, introduced the report for East Grinstead Sports Club (EGSC) which requested the Panel to consider and decide upon the applicant's request to vary the details of the project to improve the facilities at the East Grinstead Sports Club. She directed the Panel's attention to the applicants whom wished to provide a presentation to the Panel.

Kevin Ellis, Treasurer of East Grinstead Sports Club, presented the work on the

development of a new strategy which was formulated following an agreement with the TLC (liaison committee which includes representatives from the cricket, badminton, football, hockey, squash and netball clubs). The TLC believes the proposed changes seek to better cater for their customer base and the improvement would maximise the use of the facilities.

Gary Needle, Chairman of East Grinstead Sports Club, highlighted that there is a need to make the gym more accessible. He confirmed that the LED lights, heating and ventilation can be achieved within the original budget and although the proposed changes does result in a bigger spend, he reassured the Panel that the differences can be financed by the charity's funds.

Duncan Kerr, Chief Executive of Wave Leisure, confirmed that the key aim is to deliver to community, in which the equipment that the organisation is looking to provide is different to that of other gyms with a focus on health development. They also intend to appoint the correct staff to deliver the right aims.

A Member noted that Wave Leisure sometimes refers their customers to the NHS however Mid Sussex District Council (MSDC) also provides the same service. He enquired what makes their service different to that provided by MSDC.

The Chief Executive of Wave Leisure explained that the organisation is good at getting commission services through the Clinical Commissioning Groups (CCGs) and believe what they are providing to be a more complimentary service rather than a competitive service. He added that the GP referral programme is focused on the provision of gym and swimming use however Wave Leisure would like to provide a different programme where they directly work with the individual to induct them into the gym and support them throughout the process.

A Member drew attention to the original grant in which the grant was requested due to a 'desperate need' to upgrade the changing rooms and wondered whether the changing rooms are still in a 'desperate need' or whether there was never actually a need for the them to be upgraded.

The Chief Executive of Wave Leisure confirmed that the TLC is looking to increase the use of the gym which would then be followed by improvements to the changing rooms as they are taking a more time-focused approach within the strategy.

The Chairman noted the gym equipment and its specialisation. He questioned whether the organisation has guarantees that the stakeholders will use the equipment.

The Chief Executive of Wave Leisure could not confirm that the stakeholders will use the equipment however stated that the improvements would make the gym more attractive to the stakeholders.

The Vice-Chairman noted in the previous report that there would a liaison committee in which reports would go to and feedback would be done. He sought clarification on whether this process was in place.

The Treasurer of East Grinstead Sports Club confirmed that TLC had brought together all stakeholders with representatives from Wave Leisure, East Grinstead Sports Club and the Charity all part of the committee. Contents of the grant application were determined by and with the committee as well as the committee drafting the masterplan which includes the proposal to improve the gym facility.

The Vice-Chairman enquired what the relationship will be between Health and Wellbeing and the gym.

The Chief Executive of Wave Leisure clarified that Wave Leisure have been successful with Lewes District Council and East Sussex County Council in which they have supported those with conditions to engage in physical activity and have built a support group to create a pathway into the gym environment whilst also giving them support throughout.

The Vice-Chairman requested a recess to consider a legal matter in private with the legal representative before continuing on with the debate.

### [The Panel recessed at 1:45 p.m. and returned at 1:50 p.m.]

The Cabinet Member for Service Delivery confirmed that after seeking legal advice from the Council's legal representative, that there may be a professional conflict as his role as a Cabinet Member for Service Delivery which oversees the delivery of leisure in Mid Sussex would be in direct competition with the applicant. He confirmed that he would remove himself from the remainder of the discussion and voting on the item.

The Chairman raised his concerns that the equipment has a finite use and the equipment will eventually need to be replaced. He suggested that the original grant can be approved or that the applicants come back with a revised proposal.

The Treasurer of East Grinstead Sports Club explained that the Sports Club wanted to put both options on the table and be transparent in the way in which the Club wanted to develop itself. He confirmed that the gym refurbishment can be done in another way and was happy to proceed with the original proposal.

Members were not supportive of the application.

#### **RESOLVED**

The Panel refused the applicants request to vary the details of the project to improve the facilities at the East Grinstead Sport Club.

The meeting closed at 2:00pm

#### Recommendations

- 3. Members of the Panel are requested to consider and decide upon:
  - i. the recommendations for each of the above applications, summaries of which are attached in Appendices A, B and C;
  - ii. extensions to special Facility Grant conditions as detailed in Appendix E
  - iii. the recommendation to award a Facility Grant of £50,867.98 to the Branch Line (see para 15)

#### **Background**

4. Applications for all grants are assessed against a standard checklist and considered by a "Grants Assessment Group" to ensure a consistent approach to the awarding of grants.

#### **Assessment Process**

- 5. Applications are assessed against four key criteria Council priorities, evidence of need, finances and impact and benefits. The maximum possible score for excellent applications which fully meet all the criteria is 12.
- 6. The applications received in this grants round have been considered by the Grants Assessment Group comprising relevant officers from across the authority together with representatives from West Sussex County Council's Partnerships and Communities Team and, unless there is a conflict of interest, the local Council for Voluntary Service.
- 7. The merit of each application is judged against the agreed criteria and a level of funding is recommended to the Cabinet Grants Panel. A summary of the assessment of each application is included within the individual project reports in Appendices A and B.

8. All organisations have met the basic criteria and specific grant criteria, i.e. are fully constituted voluntary and not for profit organisations, and have provided the relevant information to support their application.

#### **Sponsorship**

9. In order to maximise the funds available, two applications for Community and Economic Development Grants totalling £5,000, if approved, will be funded through available monies in our sponsorship and tourism budgets. The nature of these applications relate to tourism and sponsorship and there are available funds of £7,246.

#### **Facility Grants Update and End of Revenue Grants Report**

10. The End of Revenue Grants Reports for Community & Economic Development Grants and a Facility Grants Update and are attached in Appendices D and E. The reports provide details of the outcomes relating to the Community & Economic Development Grants awards and the progress of capital projects funded through the Facility Grants scheme in 2017-18.

#### **Other Options Considered**

11. The grants provided by this Council are 'pump priming' in the context of enabling the applicants to lever in substantial monies from other organisations, grant-giving charities and national schemes.

#### The Branch Line

- 12. On 19 June 2018 the Cabinet Grants Panel considered a Facility Grant application from the Branch Line regarding the construction of a Learning Centre attached at the side to the Sussex Miniature Locomotive Society Club house in Beech Hurst Gardens. Members of the panel raised concerns about the sustainability and financial viability of the project and requested that the application be deferred until more information was provided.
- 13. Since the previous submission, the Charitable Incorporated Organisation has been registered with the Charity Commission (Ref: 1178407), planning approval has been given for the project (Ref: DM/18/1003) and a website has been established <a href="https://www.branchlinelearningcentre.com/">https://www.branchlinelearningcentre.com/</a>. In December 2018, the Chairman of the Branch Line submitted a Business Plan providing further information in support of the application.
- 14. The Learning Centre will be open to the public at the same time as the miniature railway, from 2-5 pm on Saturdays and Sundays between Easter and the end of September, on Bank Holidays and Wednesdays during the 6-week school summer holidays. This is typically over 65 open days per annum.
- 15. Approximately, 22,000 people ride on the miniature railway during these times and the aim is to attract 10% of these visitors to the Learning Centre. A £2 entrance fee should yield an annual income of £4,400 which should be sufficient to cover basic overheads which are estimated at £4,200 per annum (insurance, utilities, maintenance and repairs, website and promotional materials). The building will be fully staffed and managed by volunteers and will be available to hire for special events and functions.
- 16. The initial set up and capital project cost is £163,876 (excluding VAT) based on tenders received from six local building companies. The CIO has submitted a number of funding bids to trusts and foundations, including the National Lottery, and

- also intends to seek donations via a crowd funding campaign and from wealthy individuals with an interest in railways.
- 17. It is recommended that the Council offers a grant of £50,867.98 toward the costs of constructing the Branch Line Learning Centre which is made up of £2,704.19 (P35/757 Land at Butlers Green Road), £24,696.65 (P35/768 Land South Side of Rocky Lane), £4,819 (PL13-000539 17-21 Boltro Road), £3,601.51 (PL13-000616 The Oaks, 36 Paddockhall Road) and £15,046.63 (PL13-000841 1-3 Church Road) Community Buildings S106 monies.

Grant offer subject to the following special conditions:

- that is can be demonstrated that the project can be funded in its entirety within
   12 months of the grant offer
- the project must be completed within 12 months of project funding being obtained
- a lease agreement to be drawn up with the Council (with the agreement of the Charity Trustees).

#### **Financial Implications**

- 18. All Facility Grants are funded through the use of S106 contributions which the Council holds for the enhancement of capacity for sport, community buildings and other purposes as a result of residential development.
- 19. Community & Economic Development Grants are funded through a dedicated budget. The current fund stands at:

- 20. The allocated to date figure includes the amount approved for CED grants at the Grants Panel Meetings of 19 June, 31 July, 16 August, and 31 October, plus grants awarded to the Sheddingdean Community Association and Windmills Opportunity Playgroup agreed through a Cabinet Member report (MIS bulletin No. 16).
- 21. An additional £8,341 has been found from unspent funds for projects approved in 2017-18 that have now completed.
- 22. If Members agree to the recommendations, this will leave an overspend of the Community and Economic Development budget by £8,991. The head of Corporate Resources is happy to allocate up to £9k over budget and will look to top this up in April if a Council underspend is identified.

#### **Risk Management Implications**

- 23. The main associated risks that may impact upon the successful implementation of the decisions arising from this report would be the inability of the funded organisations to carry out the services, activities or equipment purchase for which funding had been awarded.
- 24. Additionally, the sharing of information with West Sussex County Council will ensure that organisations are not being double-funded for the same purpose.

- 25. A Contract is signed at the application stage by organisations seeking funding that details the terms and conditions under which the grant is given, including the return of all monies to the Council should the purpose for which the grant is awarded not materialise. In respect of Facility Grants, the Council may impose additional safeguards.
- 26. All organisations are requested to complete an End of Grant Report at the end of the funding period and required to submit information relating to the grant including purchase invoices, details of the number of residents benefiting from the grant, annual accounts, how the grant was used etc.
- 27. It is considered that these measures would mitigate the main risks from materialising and indicate a low-risk to the successful outcomes arising from this report.

#### **Equality and customer service implications**

28. As part of the assessment process all of the organisations applying for funding from the Council have complied with the required conditions of funding and have the requisite policies and procedures in place including any other relevant legislation.

#### **Legal Implications**

29. The Council is not obliged to provide grant funding, but by virtue of section 1 of the Localism Act 2011, it is able to do anything which it considers is likely to achieve the promotion of the economic, social or environmental wellbeing of its area. This includes the incurring of expenditure, giving financial assistance to any person (or organisation) and entering into arrangements or agreements with any person.

# Summary of project proposal and aims:

Grant toward upgrading and improving the equipment at the Chapelfields play area.

#### **Background**

Chapelfields Residents Association (CRA) was formed in 2009 to represent the interests of the 67 freehold owners of Blunden Drive, Burrell Green, Callender Walk, Chapelfields Nos 46-54 and Farr Close and deal with the day to day management of the communal areas.

The playground was provided by the developer of the properties and is managed by the residents association. The existing equipment was installed in the late 1990's and is not particularly suitable or appealing to younger children. The residents was to upgrade and improve the play area by removing some of the older equipment and replacing it with new, more stimulating equipment with play value better suited to children aged three years and above.

The equipment will be multifunctional offering more exciting play, allowing the children to use their imaginations and develop their motor skills. It will be made of wood so that it blends with the existing landscape and will incorporate climing walls, slides and balancing beams. The playground is surrounded by green open space and the children will be able to play and run around in view of their parents

and carers. The residents want the play area to be fun, exciting and safe; a place that local families with children want to visit all year round.

The residents association has obtained two comparative quotes and selected the most competitive. The price includes groundworks, a wooden ship and a climbing frame and grass turfing. The work is scheduled to take place during July – August 2019.

#### **Head of Finance Comments**

Unaudited accounts have been submitted for the period ending 31st March 2017 which show a surplus of £2,266.

Total income was £16,012; mainly generated from Subscriptions (£14,740) and Affinity Sutton (£1,272).

Total expenditure was £13,746; consisting of Supplies and Services (£13,746). Balances held at the end of the period showed Net assets of £20,392.

# How does the project meet the Council's aims?

**Strong and Resilient communities:** The new and updated play area will encourage more families to take their children out to play which will help develop stronger family and community bonds. The local residents will take responsibility for the installation and ongoing maintenance of the playground.

# **Corporate Grant Assessment Group evaluation of the project**

The assessment group feels that this project to modernise the play area and provide new equipment for younger children will benefit local families living in Chapelfields and the residents of the new housing development East of Ardingly Road. The Section 106 contribution was provided to upgrade and increase capacity at the existing play area and it is very positive that the Chapelfields Residents' Association has taken responsibility for moving the project forward.

Overall score: 8

# **Background Information**

4Sight Vision Support is a leading sight loss charity supporting visually impaired people in West Sussex. They provide a person centred approach to their services to ensure that those with sight loss do not lose their independence or become isolated as a result of their disability. Services include practical support, social and leisure activities, assistive technology training, assistive equipment, information, advice and guidance, advocacy and sight care advisors in local hospitals.

They are applying for a grant to provide low vision assessments to people in Mid Sussex in their own homes. The assessment last around one hour and is tailored to the individual's needs and ensures the person is offered the correct level of magnification and dedicated time is taken to be shown how to use the vision aids correctly. This will help to enable people to complete tasks and live more independently in their own homes and give them more confidence to partake in social activities. The assessments cost £80 per person – the grant will ensure that any financial barriers to this service are eliminated. Despite an increasing membership, 4Sight have recently seen a decline for requests in this service because of the cost.

Funding has been secured from local Town and Parish Councils and local Lions groups to the value of £2,350, with the remainder (excluding the MSDC request) to be raised through fundraising efforts.

#### **Head of Corporate Resources Comments**

- Independently examined accounts have been submitted for the period ending 31st March 2018 which show a deficit of £58,404.
- Total income was £416,895; mainly generated from Charitable activities (£142,709), Grants (£86,747), Other Trading activities (£80,980), Legacies

(£48,269), Donations (£45,391), Other income (£12,594) and Investments (£205).

- Total expenditure was £475,299; consisting of Staff Related (£269,674),Supplies and Services (£118,808), Premises Related (£68,687) and Depreciation (£18,430).
- Balances held at the end of the period showed Net assets of £1,089,705, comprising of Tangible Assets £474,705, Investments £100, Cash £660,822, Debtors £69,101, Stock £6,163 and Creditors (£121,186).

#### **Corporate Grant Assessment Group's Evaluation of the Project**

4Sight Vision Support is a well-established charity who will be able to provide a much needed service for visually impaired people in Mid Sussex to improve the quality of their lives. This service is not otherwise provided in the District and the assessment group consider this to be a good use of funds for those where lack of affordability is a barrier to these services. The panel may want to make a condition of grant that MSDC funding is only provided to those who do not have the means to pay for these services.

Overall Score: 9

### The Project Meets the Following Corporate Objectives

**Effective and Responsive Services** – Providing people living with sight loss the skills and tools to live independently and participate fully in their community to remain included.

**Strong and Resilient Communities** – The assessments will enable them to live more safely and independently and encourage confidence to participate in their community, and also reduce risk of mental health issues by combating isolation.

That the sum of £4,803.75 from the Community and Economic Development Fund be agreed as a contribution towards the outreach low vision assessments for those in need.

# **Background Information**

Bentswood Community Partnership's (BCP) key aim is to improve the lives of residents within the Bentswood Ward by bringing together residents and agencies to identify local issues and to work together to make a difference. The BCP facilitates various youth activities and organises many community events and initiatives, working in close partnership with local stakeholders to offer services and opportunities for local residents to build community resilience, upskill residents and promote community pride.

The BCP wish to continue to run its youth outreach project which has been running weekly for the last 18 months and delivered by Sussex Clubs for Young People. Activities include arts and craft and games on the green in good weather and the young people are involved in the planning of activities. A key aim for the project is for the trained workers to engage and build a rapport with "hard to reach" young people which will enable them to promote key messages around drug use, anti-social behaviour, inclusivity and self-esteem. There has been a concern with drug use and littering although anecdotally there appears to have been some improvements since this project started.

Some of the young people will have an opportunity to become young leaders in their community which would build their self-esteem and give them valuable life skills as well as being a positive influence on their peers. In addition some of the parents are becoming more engaged in the project and BCP are planning to bring some of them on as support volunteers which would enable them to be better role models and build their own confidence.

The project is currently receiving Clarion funds through the Mid Sussex Partnership, although this will end at the end of May. They have secured a further £2,826 from Clarion and are requesting a CED grant of £5,000 which will enable the project to continue until the end of February 2020.

# **Head Of Corporate Resources Comments**

- Unaudited accounts have been submitted for the period ending 31<sup>st</sup> August 2017 which show a surplus of £2,901.
- Total income was £9,471; mainly generated from Grants and donations (£9,471).
- Total expenditure was £6,570; consisting of Supplies and Services (£6,570).
- Balances held at the end of the period showed Net assets of £24,194, comprising of Cash £24,194.

# **Corporate Grant Assessment Group's Evaluation Of The Project**

The project is providing a much needed service for young people in the most deprived ward of the District, involving young people and their families directly in the project and providing opportunities for young people. It not only meets the council's priorities in many aspects, but also complements the work of the Community Safety Task and Finish Group (which reports to the Mid Sussex Partnership) on youth engagement and preventing/reducing issues around ASB.

# **Background Information**

Disability Access - East Grinstead Area promotes the rights and interests of disabled people and works to ensure, as far as practically possible, that they are not discriminated against with regard to access to and use of commercial and public services and premises.

The Group works with local planning authorities ensuring that applications do not infringe disability legislation. They also work closely with highways authorities, transport providers and facilities to ensure access opportunities for all. The Group also runs an ever growing and active free loan service for mobility equipment including electric scooters, manual wheelchairs and other mobility aids, which is very much valued by the users and their carers.

The Group organises, in cooperation with WSCC Library Service, the East Grinstead Visually Impaired Readers Group which meets at the library each month. The Group funds purchase of equipment for the members and also taxi transport to and from the meetings. Provision of taxi transport, free of charge, to the members is essential in ensuring continuation of the group which provides intellectual interest and social contact.

They are requesting MSDC funding towards overheads to support the above projects. Grants of £500 and £2,000 have already been secured from East Grinstead Town Council and East Grinstead Common Good Trust respectively.

#### **Background Information**

EGTSRC have 8 tennis courts and 3 squash courts which are also used for racketball. They run teams for both squash and tennis and provide regular coaching for juniors in both tennis and squash. They run internal tennis, squash and racketball leagues and participate in tournaments. Throughout the summer they organise tennis 'mix-ins' for juniors to encourage them to play with adults. They provide tennis court access to Imberhorne school pupils with a teacher one afternoon a week.

EGTSRC has successfully offered a new programme of healthy lifestyles, physical activity and leadership development activities targeting children and young people within the East Grinstead area and were awarded the Club of the Year award for the East Grinstead area by Mid-Sussex Active in 2018 for this work. However, this programme was not offered to all the primary schools in East Grinstead and surrounding villages and a grant will enable them to extend it to other schools.

The club will work with 13 local primary schools plus Imberhorne and Sackville secondary schools in East Grinstead to deliver new extra-curricular activities on school sites and at the community club for children and young people aged 7-18 years. In addition, young volunteers will have the opportunity to undertake new coaching &leadership qualifications alongside mentoring from an experienced instructor.

In addition to the sporting activities, guidance and literature will be provided to participants about a healthy balanced diet for sport. They also plan to link in with the Imberhorne Young Enterprise Team (year 12s) who are working on a project called 'Cook your look'. This would also help the students as they want to publicise the magazine that they are going to produce which is all about cooking and eating healthy meals.

To help develop the project, both pupils and teachers at the targeted secondary and primary schools were consulted. Feedback from teachers has driven the healthy eating and volunteering aspects of the project, with young people themselves giving feedback outlining the activities they would like to take part in. This has helped to develop a multi-skill approach to the sessions where participants can try out a number of activities, keeping sessions fun and interesting with the young people returning each week. Feedback helped to identify potential youth leaders who would be interested in gaining qualifications, training and volunteering as part of the project. To launch the project, the club will host an open day at their premises where local schools will be invited to attend and take up additional sessions. Delivery of the activities will be led by trained and qualified coaches and all activities will be offered free of charge and open to all regardless of background.

The grant is required to meet the cost of the coaching. Other costs will be met by the club who will also provide necessary equipment.

# **Background Information**

EG Town Action Group are a fairly new organisation who were established at the end of 2016 and organise regular litter picks around the town, usually attended by 20-25 volunteers – many volunteers do litter picking in their own areas of the Town. The aim of the group is to make East Grinstead cleaner and greener. The group held meetings with local councillors and residents after they set up and the overriding issue was the amount of litter around the town.

The group is seeking funding to purchase litter pickers and hi-viz jackets (which they currently borrow), insurance, publicity costs in order to raise their profile in the Town plus bulbs and flower seeds to brighten the town. As part of raising their profile, they intend to engage with shopkeepers and businesses to encourage them to keep their area clean and tidy.

Since applying for the grant, the applicant has confirmed that they have since received a grant from the East Grinstead Common Good Trust for £665 which will cover some of the costs. They have also received a grant from Clarion for a separate project to clean up a community orchard.

# **Background Information**

The Town Council promotes East Grinstead and provides local services including; allotments, cemeteries, town events, tourism services, supporting local charities, liaising with statutory services for the good of the town, statutory consultee for local matters, undertaking minor works- community via contracts with MSDC and WSCC (graffitti removal), provides litter bins, notice boards, street furniture, maintains buildings for community hire (East Court and Old Court House), maintains Town Clock, public toilets, McIndoe Statue, flower beds and civic planting.

A grant is requested towards the free East Court Live summer outdoor music events plus an event to mark the 250th anniversary of the historic East Court Mansion and other community events as they arise. The funding will allow the events to be professional and varied and in the case of the anniversary. historically informative with a photographic exhibition and period entertainment. Due to the success of past events, expectation and demand continues to grow.

The Town Council provides the concerts to the public as part of its overall town promotion. These continue to grow in popularity and from original attendances of a couple of hundred are now attracting 2000+people per event. The majority are East Grinstead residents who compliment and pass on their thanks and thoughts for future years, completing surveys at and after the events. Local acts, schools and community groups are given a chance to perform to a large audience where they might not be given this opportunity elsewhere. This is now well established and helps to create a good community feel in the town. The Council continues to monitor the size of the events due to the restricted parking and potential disruption to neighbours. EGTC is mindful about keeping the events local and ensuring that they are perceived as local events delivered by the Town Council.

As part of the East Court anniversary celebrations, The Town Council will provide an exhibition which will tell the story of the mansion and grounds which will run from March to the end of the year. With the grant, EGTC will put on an event in the Summer which may be a picnic or a costumed ball from the Georgian era. Depending on the grant, this will be a Mayoral hosted event, or a picnic with people using the terraces, house and grounds to celebrate and music and entertainment (possibly theatrics) through the ages.

# **Background Information**

The Friends of the Green Circle Network is a registered charity that carries out conservation work in and around Burgess Hill, as well as providing informative and educational activities concerning wildlife and wildlife habitats throughout each year. It costs £6 per year to join and members receive quarterly newsletters.

They organise various activities which are free of charge, except for the indoor talks for which a small admission charge of £2 - £3 is made to cover the cost of speaker and hall, though even these are free to under-16s. The Children's Safari in 2018 attracted over 300 people and the 2018 "Wild About Mid Sussex" exhibition was attended by over 3,000 people.

"Wild About Mid Sussex" is a free wildlife exhibition celebrating the wonderful countryside that surrounds the towns and villages of Mid Sussex. It's a fun day out for the whole family and provides a great opportunity to discover more about local wildlife and how to protect it. Wildlife Conservation Groups provide informative displays and exhibitions to help local people find out about protecting local wildlife.

The 8<sup>th</sup> "Wild About Mid Sussex" wildlife and Country Conservation Event is planned to take place in St. John's Park, Burgess Hill on Saturday 1<sup>st</sup> June. The applicant is planning to involve local universities by attracting more of the 14 - 25 age group. The event will emphasise the vital importance of pollinating insects and wildflowers to ensure the future of our fruit and vegetables plus a range of live exhibits.

The applicant is seeking funds toward the cost of the hire of two port-a-loos for exhibitors and staff; 60 trestle tables; advertising in the Mid Sussex Times plus the hire of a security guard and dog for 3 nights due to previous anti-social behaviour during the night in St. John's Park.

#### **Background Information**

The Hurst Festival has been established for a decade and is a not for profit organisation that arranges a festival of affordable events including professional musicians and authors amongst many other items for the local community in and around the village. The two week Festival now extends well beyond its original arts focus to touch as wide a spectrum of the local community in and around Hurstpierpoint as possible.

The proposed Music Club aimed at young people (13 – 19 year old) would be a weekly free activity throughout the year. The club would be based at Court Bushes and provide somewhere for teenagers to go to hang out, be inspired, entertained and learn skills that might help them in future employment. The club will include workshops, demonstrations, inspirational speakers, guest musicians and bands, as well as general experimenting with music and performance.

Individuals who may never have thought of trying out a classical music concert, or a theatre performance are encouraged and supported to do so. All age groups and elements in the Community will find something for themselves in the Festival. A substantial number of individuals in the community will also benefit from the contribution they make to the Festival - as volunteers, as paid performers or event leaders, or as local tradespeople who take advantage of the market provided by the Festival.

The Community Hub Building, which is owned by MSDC has recently undergone a partial rebuild and refurbishment to bring it back into community use following a fire at the end of 2017. There are currently no community facilities for residents in this area of Hurstpierpoint and this is a flagship MSDC project which will enable local community groups and residents alike to make use of a much needed facility.

The Project Meets the Following Corporate Objectives

**Financial Independence** – After an initial set up period, estimated to be around 3 years, the Community Hub is expected to become cost neutral and self sustaining via bookings income.

## **Background Information**

Lindfield Arts Festival runs an annual community event which provides and delivers a varied, exciting arts programme for the local community, utilising a wide range of venues including Lindfield High Street, community buildings, local churches, schools, shops and The Common. The aims are to encourage social cohesion and a sense of community.

Established by a group of unpaid volunteers in 2010, the Festival offers local amateur and professional Sussex artists, actors, musicians, craftsmen and creative leaders the opportunity and platform to showcase and share their talents over a weekend in September.

The Festival is seeking funds to contribute towards the cost of hiring the Applause Outdoors Company to deliver performances and entertainment for all ages and abilities during Lindfield Arts Festival.

Applause Outdoors will provide two events – a part man, part tree character called Arbor who provides an interactive street theatre performance, using puppets and telling a story of a tree pushed from his home and fighting to preserve his future which will provide an important message to the audience as well as being entertaining. Encouraging the audience to plant and nurture their own trees, Arbor will give each family a sapling to take home, leaving a lasting legacy.

The second event is a mashup of dance and table tennis. The Guardian Doubles will provide a unique performance of dance and ping pong. The dancers spin and slide in a pop-up performance that smashes expectations of dance and

advocates the importance of safe, positive and accessible public spaces. Families will be encouraged to play ping pong after watching the show.

Both activities will be free of charge to everyone.

## **Background Information**

Pericles Theatre Company, which is part of the Hoathly Hill Trust, a charitable company delivers high artistic standard performances with actors with and without learning disabilities and professional musicians. In this way a dynamic space is co-created, in which learning disabled adults can thrive, as equal contributors alongside professional actors and musicians who hold the framework of the story.

Their project for 2019 will be a family show adapted from the original Fairy Tale of Hans Christian Andersen's 'The Little Mermaid'. There will be 15 participants of which these 10 have disabilities. The participants will start the process and work with the Director by adapting the fairy tale into a 3D drama suitable for the stage, arranging the music, designing and creating the props, masks, set and costumes. During this process a wide variety of craft skills are worked with, including green wood turning, wood carving, furniture making, pottery, maskmaking, weaving, basket making, felting, sewing and knitting. After the adaptation the cast will then move to rehearsing, adapting and fine tuning the play and developing the roles around the unique skills and contributions of each individual.

There will be about 10 performances in Village Halls, Arts Centres, Festivals, communities, Schools and Colleges. Most of the performances are taking place within the district although there will be one at Chiddingstone Castle and some at Forest Row Village Hall which is just outside the border of Mid Sussex. Other performances will take place at West Hoathly, Sharpethorne, East Grinstead and Haywards Heath. Most of the income for the project will be generated from income sales, donations and crowdfunding. Pericles are requesting a contribution towards the Director's and Producer's fees, costs towards adaption of the play and the costs of puppetry and light design.

## **Head Of Corporate Resources Comments**

- Independently examined accounts have been submitted for the period ending 31st March 2017 which show a deficit of £12,000.
- Total income was £30,049; mainly generated from Pericles Theatre (£17,234), Studio (£3,874), Rent received (£3,275), Service charge (£1,736), Rural Payment Agency (£1,386), Subscriptions (£1,090), Donations & Gifts (£585), Other Income (£534) and Dividends and Interest (£335).
- Total expenditure was £42,049; consisting of Supplies and Services (£34,298) and Premises (£7,751).

## **Background Information**

Smart Dog Education is a social enterprise which was set up in 2017 offering training and accreditation in business and customer service for those with disabilities who are over 16. It is a Community Interest Company Limited by Shares, with one Director owning 100 shares of £1 each. The applicant works with people with learning disabilities, particularly those on the ASD spectrum to help them towards their first adult goal in life, whether it is a job, training, education or a social relationship. They have found that a number of those they have trained since setting up have limited social mobility or personal interactions apart from with their parents or carers which can be a barrier to them attaining interviews, work experience and employment.

Smart Dog Education plans to start up a club in Haywards Heath for people with learning and physical disabilities to promote social inclusion help them to take their next step in adult development. The aim is to improve confidence, build relationships, and equip members to be ready for a first work trial, job or relationship in a non-judgemental and supportive environment with trained volunteers and staff facilitating monthly meetings.

- Unaudited accounts have been submitted for the period ending 30<sup>th</sup> January 2018 which show a surplus of £1,750.
- Total income was £6,750; mainly generated from Grants (£6,750).

# **Corporate Grant Assessment Group's Evaluation Of The Project**

This is a new Community Interest Company with no known track record. The Director had set up a similar CIC at the end of 2014 which closed down a couple

of years later. In addition, some of these activities, specifically to help people with learning disabilities and those on the autistic spectrum to become job ready are already being undertaken in Mid Sussex by a long established charity, the Aldingbourne Trust, who are contracted by WSCC to do so. For these reasons, the assessment group is cautious about offering a grant to this organisation and would not recommend funding for this.

## **Background Information**

St Peter &St James Hospice offers high quality, compassionate end of life care and support to people with a terminal illness. It supports nearly 700 patients a year and also offers support and bereavement care to their families, carers and friends. Approximately 70% of patients are Mid Sussex residents.

The hospice offers an extensive wellbeing service for patients, carers and bereaved families via its Beacon View Centre, which is used regularly and is particularly helpful to patients living at home as they can come into Beacon View once a week and take part in activities, talk to our nurses and meet new friends. Activities and therapies in the centre include physio-therapy, aromatherapy, gentle exercise classes, breathing and meditation sessions as well as creative classes like art, music and writing. The Centre also holds talks by different specialists and holds regular 'Ask the Nurses' sessions, plus time for patients and carers to talk with counsellors and welfare advisors.

Funding is required to purchase an air conditioning unit for the Beacon View Centre which will make the area more comfortable for patients. During the summer the room can get very hot and it is difficult to control the temperature. Many people living with a terminal illness experience periods of high temperatures and sweating, so excessive heat in addition to this adds to their discomfort.

The hospice has requested a donation from Haywards Heath Town Council and also intend to fundraise for the balance.

## **Head Of Corporate Resources Comments**

• Independently audited accounts have been submitted for the period ending 31st March 2018 which show a surplus of £265,922.

- Total income was £4,439,439; mainly generated from Donations (£1,274,151), Shop Income (£1,107,256), Legacies (£900,019), Grants (£720,159), Income from Charitable activities (£417,520) and Investment income (£20,334).
- Total expenditure was £4,173,517; consisting of Staff Related (£3,066,918), Supplies and Services (£1,101,983) and Loss on investments (£4,616).

It will also make the venue more comfortable and usable for all patients.

**Strong and Resilient Communities** – Air conditioning will improve the Wellbeing Centre, which is a centre for activities and therapies for a community of people at the end of their life. A wide range of activities and therapies are offered, specifically aimed at people who have a terminal illness, or are caring for people with a terminal illness.

That the sum of £2,569 from the Community and Economic Development fund is provided towards the cost of an air conditioning unit for the Beacon View Centre.

# **Background Information**

West Sussex Mediation Service (WSMS) was established in 2000 and is based in Horsham and delivers across the county. WSMS aims to improve the lives of residents by offering a wide range of mediation services, many of which are free at the point of delivery. They specialise in neighbour disputes over issues such as noise nuisance, antisocial behaviour, rubbish, parking, trees, hedges, boundaries, building works disputes etc. Volunteer mediators work in pairs, within their local community visiting clients in their own homes and use local venues, close to where the clients live, to hold the formal mediation sessions.

WSMS have been serving Mid Sussex residents since 2003 when the local mediation service folded due to lack of funding. Mid Sussex is the second busiest District across the county, in terms of referrals and has been so for the last 6 years. WSMS have a good relationship with MSDC and many referrals for mediation is through MSDC officers or the local Police. They maintain a good number of local trained volunteer mediators to serve the District and take an active role in promoting the service.

Funding is required to continue the support of free mediation services and conflict coaching to Mid Sussex residents. Successful mediation will improve the wellbeing of local residents as well as easing the strain on local Council and Police services and prevent situations that may otherwise escalate.

The applicant has secured funding of £6,800 from Clarion Housing, Sussex Police and Crime Commissioner's Office, Hurstpierpoint and Sayers Common Parish Council, Lindfield Parish Council, Lindfield Rural Parish Council and Hassocks Parish Council. They also generate income from paid services that can't be provided for free, such as family mediation (divorcing and separating couples) and Workplace Mediation.

## **Head Of Corporate Resources Comments**

- Independently examined accounts have been submitted for the period ending 31st March 2017 which show a surplus of £4,757.
- Total income was £88,011; mainly generated from Grants (£62,531),
   Paid mediation (£22,330), Fundraising (£2,221), Donations (£911)

- Total expenditure was £83,254; consisting of Staff Related (£53,872) and Supplies and Services (£29,382).

WSMS offer a range of free mediation services and estimate that 350 clients from Mid Sussex will benefit from this award which will cover volunteer expenses, room costs, mediation, conflict coaching and publicity materials. They have a good working relationship with the local police and with MSDC officers – many referrals for mediation come from the Council or the Police and the Assessment Group feels that this service should continue to be supported.

Overall Score: 12

## The Project Meets the Following Corporate Objectives

**Effective and Responsive Services** – All sections of the community are served, regardless of their backgrounds. This includes travellers, ex-offenders, migrant workers and various ethnic and marginalised communities. Provision is made for individuals' needs where necessary. Volunteers undergo additional training to understand different communities' lifestyles and traditions.

**Sustainable Economic Growth** – A wide range of volunteering opportunities and a variety of training courses are provided which enhance life skills and employment opportunities. These roles include training as a mediator, becoming a trustee, fundraising, marketing, publicity, and administration.

**Strong & Resilient Communities** – Client feedback questionnaires have been shown to improve health and wellbeing as a result of addressing conflict and thus helping to improve people's lives. A number of WSMS volunteer mediators are previous clients who have experienced mediation first hand.

#### Recommendation

That the sum of £3,000 from the Community and Economic Development fund is provided towards the cost of mediation services in Mid Sussex.
