

Purpose of Report

1. This report sets out the role of the Chairman and Vice Chairman of the Council and provides background to support the Council makes these important appointments.

Recommendations

- 1. That the Council elects a Chairman and Vice Chairman for the municipal year 2023/24 as outlined below:
 - a. The current Chairman of the Council, Councillor Margaret Belsey will conduct the election of a new Chairman at the meeting in accordance with the detail in paras 7 to 11 below.
 - b. The newly elected Chairman will then conduct the election of the Vice Chairman (paras 12 to 13) for the municipal year 2023/24.

Background

- 2. District councils are required by law to elect a chairman each year. The election is carried out by Full Council at the Annual Council meeting. The Chairman of the Council will not necessarily be a member of the majority political group on the Council. As the chair of Full Council meetings, he or she is expected to be completely impartial in this role.
- 3. The Chairman is the Council's civic head, and as the first citizen of the district takes precedence within the district over everyone except His Majesty the King or his representative (usually the Lord Lieutenant of West Sussex).
- 4. The Vice-Chairman can deputise for the Chairman and performs similar duties.

The role of the Chairman of the Council

- 5. Part 5 (viii) of the Council Constitution details the key roles of Councillors. In addition to the role of Councillor, the Chairman of the District Council's Role includes carrying out the following duties:
 - a) To act as first citizen of the District;
 - b) To uphold and promote the purposes of the Council's Constitution, and to interpret the Constitution when necessary;

- To preside over meetings of the Council so that its business can be carried out efficiently and with regard to the rights of Councillors and the interests of the community;
- d) To ensure that the Council meeting is a forum for the debate of matters of concern to the local community and the place at which members who are not on the Cabinet or do not hold Committee Chairs are able to hold the Cabinet and Committee Chairmen to account:
- e) To promote public involvement in the Council's activities;
- f) To be the conscience of the Council; and
- g) To attend such civic and ceremonial functions as the Council and they determine appropriate
- h) To network with external organisations such as County and Town and Parish Councils, Voluntary Organisations etc
- i) To understand and interpret the Council's Procedure Rules, structure of the Authority and the roles of responsible officers
- j) To be aware of local issues which affect Council business
- k) To promote the well-being of the District
- I) To encourage high standards of probity

The role of the Vice Chairman of the Council

- 6. Part 5 (viii) of the Council Constitution details the key roles of Councillors. In addition to the role of Councillor, the Vice-Chairman of the District Council carries out the following duties:
 - a) To fulfil the role of the Chairman in their absence from meetings of the Council
 - b) To support the Chairman as necessary and to facilitate the effective running of meetings
 - c) To represent the Council and the community in the Chairman's absence

Procedure for electing the Chairman of the Council

- 7. The current Chairman of the Council, Councillor Margaret Belsey, will preside at the meeting until a new Chairman of the Council has been elected. More than one nomination may be proposed.
- 8. Councillor Margaret Belsey will call for nominations to the position of Chairman.
- 9. A member of the Council must be nominated to fill the position of Chairman of the Council, with a proposer and seconder. The nominated person must confirm that she/he is willing to fulfil the role.
- 10. Councillor Margaret Belsey will conduct a vote, and all members of the Council may vote. If more than one person is nominated, voting process will continue until a majority is given in favour of one person is achieved.

11. The Chain of office will then be transferred, and the newly elected Chairman of the Council will then take over the meeting. He/she will thank the out-going Chairman and conduct the election of the Vice Chairman.

Procedure for electing the Vice-Chairman of the Council

- 12. A member of the Council must be nominated to fill the position of Vice-Chairman of the Council, with a proposer and seconder. The nominated person must confirm that she/he is willing to fulfil the role. More than one nomination may be proposed.
- 13. Again, a vote will be held, and all members of the Council may vote. If more than one person is nominated, the voting process will continue until a majority is given in favour of one person.

14. The constitution specifies the roles as special responsibilities to which special allowance, on top of the basic allowance, is payable annually as follows:

Purpose of Report

1. The purpose of this report is to set out the political balance of the Council for the term of this Council 2023-2027, and the political balance of the committees of the Council.

Recommendation

- 2. Council is recommended to:
 - a) Note the political balance of the Council.
 - b) That for the municipal year 2023/24 the composition of the Council's committees be as set out at paragraph 9 of this report.

Background

- 3. Section 15 of the Local Government Act 1989 and the Regulations made thereunder, require the Council to regularly review the political composition of the Council and to determine the size and constitution of its Committees etc. to ensure that the political balance is reflected and maintained in those Committees, Sub-Committees and Working Parties by allocating seats on each Committee to each group in direct proportion to each group's overall representation on the Council.
- 4. In accordance with legislation, the Council is required to consider the political balance of the Council and to determine the allocation of seats on Committees.

The Rules and Principles of Political Balance

- 5. Following the coming into effect of the Local Government Boundary Commission's recommendations, the Council now has 48 councillors. The political composition of the Council is now: Liberal Democrat 20 seats (41.75%); Conservative 18 seats (37.5%); Green 4 seats (8.33%); the Independent group 4 seats (8.33%); Burgess Hill Independent 1 seat (2.08%); Labour 1 seat (2.08%).
- 6. This means that the Council is in a position of no overall political control, i.e., no single group has a working majority. This is the case for many Councils in the region. In this scenario Councillors across the parties will need to work together to create consensus. Councillors will need to collaborate to ensure collective governance that provides stability for the Council, and therefore for the residents of Mid Sussex.
- 7. The principles of political balance require that:
 - (a) not all seats on any committee or sub-committee are allocated to the same group;

- (b) the majority of seats on the committee/sub-committee are allocated to a particular group if that group has a majority of seats on the Council;
- (c) subject to (a) and (b) above that the number of seats allocated to any group on the total of all committees have the same proportion to the proportion on the full Council; and
- (d) subject to (a), (b) and (c) above that the number of seats on each committee allocated to each group bears the same proportion to the proportion on the full Council.
- 8. Through its constitution, the Council has established the following committees, each with the following number of members:

Committee	Membership
Scrutiny (People and Communities)	11
Scrutiny (Place and Environment)	11

Licensing	15
Standards	6 (plus 4 Parish/ Town representatives)
Audit	7

Recent cross-party work to update the Council's Constitution sought to enhance the role of scrutiny by broadening the scope of the Scrutiny Committees. Therefore, they have been re-named and their scope is outlined below:

People & Communities: overall budget & policy framework, health & wellbeing, community safety, partnership working, equalities, revenues & benefits, waste & recycling, housing, environmental health.

Place & Environment: planning, leisure, parking, parks & open spaces, economy & sustainability, asset management.

It is hoped that this themed approach will provide an opportunity to consider more strategically the issues that matter to residents and to take the opportunity to have a broader approach to scrutinising strategy, policy and decision-making. This broader emphasis will also enable members to have a wider focus including considering the role of partners/ agencies.

9. In accordance with the principles set out above, this report proposes the composition of the committees to be as follows:

Purpose of Report

1. The purpose of this report is to provide background to the appointment of the Executive Leader of the Council for the period ending on the date of the Annual Meeting in 2027 in accordance with the requirements of the Constitution and the Local Government Act 1972.

Recommendations

- 2. Council is recommended to:
 - a) To appoint the Executive Leader of the Council for a term of 4 years ending on the date of the Annual Meeting in 2027; and
 - b) Note the appointments to Cabinet positions and their portfolios.

Background

- 3. The Executive Leader ("Leader") will be a councillor elected to the position of Executive Leader by the Council at the First Annual Council Meeting; they hold office for four years or unless they:
 - a) resign from the office; or
 - b) are no longer a Councillor; or
 - c) are removed from office by resolution of the Council, provided that notice of any motion which would have the effect of removing them from office is delivered to the office of the Chief Executive not less than 10 clear days before the relevant Council meeting signed by at least 14 Councillors.
- 4. The Executive Leader is responsible for determining the Council's executive arrangements, including the appointment of Cabinet members, their portfolio responsibilities and how the executive functions are exercised.
- 5. The Executive Leader must appoint a Deputy Leader who holds the office until the end of the Executive Leader's term of office unless they resign from the office, are no longer a councillor or are removed from office by the Executive Leader.

The Role of the Executive Leader

6. Part 5 (viii) of the Council Constitution details the key roles of Councillors. In addition to the role of Councillor, the Executive Leader of the District Council carries out the following duties:

- a) To be the political Head of the Authority
- b) To provide political leadership and inspire and communicate a vision and strategy that is well understood and supported by other politicians and the community
- c) To represent and lead the majority group in the Council and to put forward the group's political views to the Council
- d) To explain and promote a need and purpose of change to other politicians and the community so that change is well understood and supported
- e) To develop relationships with stakeholders to promote and achieve a positive image of the District Council
- f) To set priorities that are well understood and supported, and to overview performance to ensure priorities are met
- g) To overview the use of financial and staff resources to ensure the Council's policies, priorities and plans are achieved
- h) To chair meetings of Cabinet
- To have primary responsibility for Corporate policy/strategy, press and public relations, corporate communications, the Council's Budget, the Corporate Plan and Value for Money
- j) To ensure effective Cabinet responsibility for corporate policy and strategy, customer services, procurement and service and financial planning.
- k) To lead and act as spokesperson for the Cabinet in its work to develop Policy Framework and budget and take overall political control of authority within agreed Policy Framework
- I) To nominate, and if appropriate dismiss and replace, the members of the Cabinet
- m) To allocate portfolio holder responsibilities between Cabinet members
- n) To provide briefings to all Members of the Council at meetings of full Council
- To develop and maintain a wide-ranging knowledge and understanding of corporate, strategic, and service issues facing the Council in order to effectively perform the Executive Leader's role
- p) To contribute constructively to open government and democratic renewal through active encouragement to the community to participate generally in the governance of the District
- q) To understand the Council's role and place within the public sector
- r) To promote the interests of the Council's community partners and to broaden the environment
- s) To promote the Council's reputation as a Community Leader
- t) To keep the Members in general up to date on issues and to provide an important link between Members

- u) To encourage high standards of probity.
- v) To serve upon the County Joint Leaders Group and work constructively with the Leaders of other Councils in West Sussex
- w) To represent the District regionally and nationally

Procedure at Council for the election of the Executive Leader

- 7. A member of the Council must be nominated to fill the position of Executive Leader of the Council, with a proposer and seconder.
- 8. The Chairman of the Council will call for nominations. The nominated person must confirm that she/he is willing to fulfil the role. It is usually the case that group leaders have agreed in advance who is to be recommended to Council as the proposed leader.
- 9. The Chairman will conduct a vote once nominations have been received. All members of the Council may give a vote. The nomination and voting process will continue until a majority is given in favour of one person.

Appointment of Cabinet

- 10. Once appointed, the new Leader will address the Council and announce the Cabinet and their portfolios.
- 11. The Leader and Cabinet will then take their places at the front of the Chamber.

Purpose of Report

1. The purpose of this report is to recommend that the Council formally 'make' the Horsted Keynes Neighbourhood Plan. The Neighbourhood Plan will then sit alongside the District Plan as part of the Development Plan for Mid Sussex and be used in the determination of planning applications in the parish of Horsted Keynes.

Summary

- 2. The District Council supports communities who wish to prepare Neighbourhood Plans. Altogether, in addition to the Horsted Keynes Plan, 19 Neighbourhood Plans have been 'made' (adopted) in the District. Once this Neighbourhood Plan is 'made', there will be full coverage across the district.
- 3. The Horsted Keynes Neighbourhood Plan has been through independent examination and received the support of the community in a Referendum. Mid Sussex District Council is required to formally 'make' the Horsted Keynes Neighbourhood Plan following a successful Referendum, unless to do so would breach, or would otherwise be incompatible with any EU obligation or any of the Convention Rights (within the meaning of the Human Rights Act 1998).

Recommendations

- 4. Council is recommended to:
 - (i) Note the outcome of the Horsted Keynes Neighbourhood Plan Referendum;
 - (ii) Formally 'make' the Horsted Keynes Neighbourhood Plan part of the Development Plan for the parish of Horsted Keynes.

Background

- 5. Horsted Keynes Parish Council is the 'qualifying body' with responsibility for preparing the Horsted Keynes Neighbourhood Plan. The Neighbourhood Plan covers the plan period 2016 to 2031 and has been prepared for a designated neighbourhood area which follows the Horsted Keynes parish boundary.
- 6. The Parish Council started the preparation of a Neighbourhood Plan for its parish in July 2012 when the Neighbourhood Plan area was designated by the District Council.

- 7. The Plan sets out a vision and objectives for the parish and, in line with paragraph 28 of the National Planning Policy Framework, it contains a series of policies on housing; the design of development; environment and green space; business and employment; and on transport.
- 8. The Neighbourhood Plan was published by the District Council for Regulation 16 public consultation from 22nd September until 7th November 2022.
- 9. In agreement with Horsted Keynes Parish Council, Mid Sussex Council appointed an Independent Examiner, Mr Andrew Ashcroft, to review whether the Neighbourhood Plan met the Basic Conditions, as required by legislation, and to recommend whether it should proceed to Referendum. The Examiner concluded that, subject to some modifications to the Plan, it met the Basic Conditions and should go forward to Referendum. These modifications were approved by Cabinet on 6th February 2023.
- 10. The Horsted Keynes Neighbourhood Plan Referendum was held on 4th May 2023. The result was 451 persons in favour and 96 against.

Making of the Neighbourhood Plan

- 11. The Neighbourhood Planning Act 2017 provides that a Neighbourhood Plan automatically becomes part of the Development Plan following a successful Referendum, holding full weight in relation to the determination of planning applications. However, the Local Planning Authority (LPA) also has a statutory duty to 'make' a Neighbourhood Plan, following a successful Referendum, if more than half of those voting have voted in favour of the plan. The LPA is not subject to this duty if (and only if) the making of the plan would breach, or would otherwise be incompatible with, any EU obligation or any of the Convention Rights (within the meaning of the Human Rights Act 1998).
- 12. The Examiner concluded that the Horsted Keynes Neighbourhood Plan, with modifications, met these legislative obligations. No information has subsequently arisen to suggest the making of the Horsted Keynes Neighbourhood Plan would be in breach with or incompatible with the legislation.

Policy Context

13. The National Planning Policy Framework and the Localism Act 2011 support Neighbourhood Plans. The Mid Sussex District Plan was adopted in March 2018 and the preparation of Neighbourhood Plans is part of its overall development strategy.

Other Options Considered

14. There are no other options as the Local Planning Authority has a statutory duty to 'make' a neighbourhood plan, following a successful Referendum, and where the Neighbourhood Plan meets statutory requirements.

Financial Implications

15. The cost of the Examination was £4,128. This, plus the cost of holding the Referendum, will be met from the Government grant which is made available to Local Planning Authorities following the publication of a decision statement.

Risk Management Implications

16. If the Neighbourhood Plan is not 'made', the Council could be at risk of legal challenge on the basis it has not met the legal requirements for Neighbourhood Development Plans.

Equality and Customer Service Implications

17. An Equality Impact Assessment was carried out at the Submission (Regulation 16) Stage of the Neighbourhood Plan. The Parish Council also prepared a Consultation Statement demonstrating how they have consulted the local community and statutory consultees. The Examiner was satisfied that the consultation and publicity undertaken met regulatory requirements.

Other Material Implications

18. There are no other material considerations.

Sustainability Implications

- 19. The National Planning Policy Framework recognises the role that planning can have in addressing and mitigating future impacts of climate change the draft policies within the Horsted Keynes Neighbourhood Plan were found to be in general conformity with national policy and ambitions.
- 20. The Horsted Keynes Neighbourhood Plan is accompanied by a Sustainability Appraisal (incorporating a Strategic Environmental Assessment). It documents, at each formal stage of the plan-making process, the impacts of the proposed policies against the sustainability criteria and informs the plan-making process by ensuring the plan is the most sustainable given all reasonable alternatives.
