Release of S106 Local Community Infrastructure (LCI) contributions - Purchase and Installation of CCTV at Mount Noddy Recreation Ground.

The Leader authorised the release of £21,257.91 from S106 Local Community Infrastructure (LCI) contributions to purchase and install CCTV at Mount Noddy Recreation Ground.

<u>Procurement of Support Service for Vulnerable Households in Temporary Accommodation</u> (EXEMPT)

The Leader authorised the award of the contract for housing support services to vulnerable childless single persons households in temporary accommodation.

Funding Affordable Housing on the Site of East Grinstead Police Station (EXEMPT)

The Leader of the Council:

- Approved in principle the payment of commuted sums ring fenced for affordable housing in the Council's approved affordable housing capital budget, to enable the delivery of new homes on the site of the former Police Station in East Grinstead subject to a successful planning application.
- Instructed the Business Unit Leader for Housing Services to enter into a grant funding agreement for the use of these monies once planning permission for the proposed scheme has been granted.
