Information and News

COVID-19 News

Covid levels in Mid Sussex have stayed at about 50 cases per 100,000 in the last week from very low levels we had in the middle of May 2021. The increase case levels in Mid Sussex are concentrated in younger age groups with indications these cases are starting to fall.

Covid rates have generally risen across West Sussex in the last week but with no areas having a rate higher than the increased England average of about 70 cases per 100,000. The average Covid rate in West Sussex is still below the South East average of about 40 cases per 100,000. Case levels in England and the South East have generally continued to rise in the last week but currently East Sussex has maintained low Covid levels.

In most parts of Greater Manchester and Lancashire and other hotspots Covid rates are well above 100 cases per 100,000 with the Delta variant being dominant, as it now is across England.

Extra efforts have been made to keep Covid levels down in hotspot areas with surge testing and additional vaccinations for all adults in these vulnerable areas and people are asked not to move in and out of these areas. These efforts have resulted in the case levels dropping in some of these areas with high levels of Covid

The third stage of the roadmap started on Monday 17th May 2021 with gyms/leisure centres, hotels and guest houses fully reopening, limited indoor home mixing and overnight stays and indoor service in pubs and restaurants. A leaflet is attached below explaining the advice to be cautious about meetings in private homes. Lateral Flow Tests are being used to identify people who have Covid but have no symptoms to try to maintain the low Covid rates now found in much of England. These free tests are available from local collection areas that can be located online or by requesting a postal delivery. Additional indoor mixing over the past four weeks and the emergence of the Delta variant do seem to have resulted in an increase in Covid levels generally in England from late May.

The roadmap envisaged most Covid restrictions being lifted from 21st June 2021 subject to the four data tests being met. Due to the rapid rise in cases and the greater dangers of the Delta variant most of the relaxations proposed for 21st June will now be delayed for 4 weeks to 19th July 2021 with a further review ahead of this date. The additional 4 weeks will allow more people to get their second vaccination does which is required to protect against the more infectious Delta variant. It is important people remember Hands Face Space and Fresh Air as more people are mixing.

Both Covid hospitalisations and Covid death rates remain low in Sussex with no significant increase to date. There have however been increased hospitalisations in hotspot areas.



The continuing local Covid vaccination programme will assist in keeping hospitalisations and Covid deaths down but indoor social mixing, the Delta variant and possible new variants of the Covid virus may continue to push the Covid figures up.

All people aged 23 and over are now eligible to book their first vaccination and will be invited to book an appointment through their GP or they can book their appointment themselves online. Anybody 23+ who has not come forward previously for their first vaccination is urged to do so and get an appointment. People that have had a first vaccination at least 8 weeks ago are also asked to enquire about their second vaccination if they have not got an appointment yet.

All those aged 18+ are likely to be invited to come forward for a first vaccination this month, vaccination supply permitting. Vaccinations take a couple of weeks to fully take effect and two doses are required. The vaccination of more medically vulnerable people aged 16 to 22 alongside the second vaccination for those people first vaccinated in April/May 2021 will also continue in June 2021. The second vaccination for people 50+ or vulnerable or an unpaid carer should be completed before 21st June 2021.

2023 Review of Parliamentary constituencies

The Boundary Commission for England (BCE) is the independent organisation responsible for reviewing **<u>Parliamentary</u>** constituency boundaries in England.

On 8th June the BCE published its proposals for new parliamentary boundaries at its website. The current review will conclude with their formal report and recommendations in June 2023, so it is referred to as the '2023 Review'. You can see a summary of the process by clicking on the 'Review process' link at the top of their web page or read a more detailed description in their <u>Guide to the 2023</u> <u>Review(external link opens in a new tab)</u>. Recent changes to the law make it very likely that recommendations from this review will be implemented, so you are encouraged to participate in the process by giving your views through the BCE website.

You can use this website to:

- view current constituency and local authority boundaries.
- view BCE proposals for new constituency boundaries; and
- submit a response directly about the proposals (during a defined consultation period).

From the second consultation period onwards, you will also be able to:

- view the responses submitted by others; and
- submit a comment directly, supporting or contesting a response from somebody else.

To help you use the website effectively, BCE has produced a short and simple step by step guide: just click on the 'How to' link at the top of their web page.



Consultation is currently open until Tuesday 2nd August 2021 - please make sure to respond by that date at the latest.

This is separate to and therefore not to be confused with the current Electoral Review of Mid Sussex District Council being conducted by the Local Government Boundary Commission (England).
