COVID-19 News

Covid levels in Mid Sussex have risen quickly in the last week to about 200 cases per 100,000 from the very low levels we had in the middle of May 2021. The increase in case levels in Mid Sussex are likely to continue over the next few weeks and are concentrated in younger age groups who have not yet been fully vaccinated. Hospitalisations and deaths locally are rising very slowly given the most vulnerable groups are now fully vaccinated and the vaccines prevent serious illness with the current Covid variants.

Covid rates have generally risen across West Sussex in the last week but with no areas having a rate higher than the increased England average of about 230 cases per 100,000. The average Covid rate in West Sussex is now slightly below the increased South East average of about 160 cases per 100,000.

In some areas of the country Covid rates are well above 300 cases per 100,000 with the Delta variant being dominant across all of England. Brighton and Hove now has a case level just under 400 cases per 100,000 and is a South East Covid hotspot.

The third stage of the roadmap started on Monday 17th May 2021 with gyms/leisure centres, hotels and guest houses fully reopening, limited indoor home mixing and overnight stays and indoor service in pubs and restaurants. A leaflet is attached below explaining the advice to be cautious about meetings in private homes. Lateral Flow Tests are being used to identify people who have Covid but have no symptoms to try to maintain the low Covid rates now found in much of England. These free tests are available from local collection areas that can be located online or by requesting a postal delivery. Additional indoor mixing over the past seven weeks and the Delta variant have resulted in an increase in Covid levels generally in England from late May but with a much smaller increase in hospitalisations and deaths which remain less than 10% of their peak in late January 2021.

About 64% of the adult population in England and in Mid Sussex are now double vaccinated and about 86% have received a first vaccination and all adults are now eligible to book a vaccination jab with the second vaccinations being done after 8 weeks. This vaccination programme is being relied on to keep hospitalisations and deaths down despite the rapid increase in Covid cases across most of England.

The roadmap envisaged most Covid restrictions being lifted from 21st June 2021 subject to the four data tests being met. Due to the rapid rise in cases and the greater dangers of the delta variant most of the relaxations proposed for 21st June were delayed for 4 weeks to 19th July 2021 to get more of the adult population double vaccinated. It is important people remember Hands Face Space and Fresh Air as more people are out and about and Covid rates increase due to the more infectious Delta variant. Most restrictions are likely to be lifted on 19th July but it is acknowledged Covid cases are likely to continue to rise through August 2021, but it is expected that the vaccination programme will keep any rise in hospitalisations and deaths to modest levels. A final decision on 19th July relaxations will be



made on 12th July based on the data in the next week looking in particular for unexpected rises in hospitalisations or any new Covid variant.

The continuing local Covid vaccination programme is central to keeping hospitalisations and Covid deaths down but indoor social mixing, the delta variant and possible new variants of the Covid virus will continue to push the Covid figures up in the next few weeks.
