#### Re-Allocation of S.106 Total Access Demand (TAD) Contributions

The Cabinet Member for Housing and Planning authorised the release of £67,076.35, previously committed to West Sussex County Council, to Mid Sussex District Council from Total Access Demand (TAD) contributions arising from developments at Land at 86 Junction Road, Land at Kings Head Public House, Land at Summerfold House, Land at 67 Victoria Road, Land at 107 Fairfield Road and Land at 71 Victoria Road to facilitate the delivery of agreed projects within the Burgess Hill Place and Connectivity Programme.

#### Proposed New Lease - Units 1-2, Orchards Shopping Centre, Haywards Heath (EXEMPT)

The Deputy Leader:

- (a) Authorised the grant of a new reversionary lease to Superdrug Stores Plc (trading as Superdrug), a health and beauty retailer, for the continued occupation to an existing tenant at the retail centre in Unit 1-2 for a term of 5 years.
- (b) Authorised the Solicitor to the Council to conclude the transaction above on the terms outlined below, and on any such other terms and conditions as the Solicitor to the Council may recommend to protect the Council's position.

## **Information and News**

#### **COVID-19 News**

Covid levels in Mid Sussex have risen further in the last week to about 440 cases per 100,000 from the very low levels we had in the middle of May 2021. The increase in case levels in Mid Sussex is likely to continue over the next few weeks and are highest in younger age groups who have not yet been fully vaccinated but significant increases are now being seen in older fully vaccinated age groups. Hospitalisations locally are rising slowly given the most vulnerable groups are now fully vaccinated and the vaccines prevent serious illness with the current Covid variants. Covid deaths locally remain very low.

Covid rates have generally risen across West Sussex in the last week but with most areas having a rate around the England average of about 470 cases per 100,000. The average Covid rate in West Sussex is now above the increased South East average of about 370 cases per 100,000.

In most areas of England Covid rates are above 400 cases per 100,000 with the Delta variant now being dominant across all of England. Brighton and Hove now has a case level at about 500 cases per 100,000 and is a South East Covid hotspot. That Covid level and above is found commonly in the NE, NW and parts of the Midlands.

Lateral flow tests are available free to collect locally or request online by post so everyone can check their Covid status and take a PCR test if the lateral flow test indicates a Covid positive result. People must self-isolate if they have a positive test or are asked to do so by Track and Trace if they have been in recent close contact with someone who goes on to test positive for Covid

The fourth stage of the roadmap started on Monday 19<sup>th</sup> July 2021. Most restrictions are lifted but the population is asked to remain cautious given we are now in a further wave of increasing Covid rates. Advice has been issued for various settings and this guidance is similar to the previous restrictions and an LGA update is attached. People are advised to use face masks in crowded indoor settings



which includes busy trains and buses and shops. Some transport operators and some supermarkets expect masks to still be worn.

About 69% of the adult population in England and in Mid Sussex are now double vaccinated and about 88% have received a first vaccination and all adults are now eligible to book a vaccination jab with the second vaccinations being done after 8 weeks. This vaccination programme is being relied on to keep hospitalisations and deaths down despite the continuing increase in Covid cases across most of England. Vaccinations per day have fallen this month across England and efforts are being made to get all adults to come forward for both first vaccinations and second vaccinations as appropriate with a lot of convenient local pop up vaccination points.
