Lease Renewal At (Unit G), The Orchards Shopping Centre, Haywards Heath (EXEMPT)

The Deputy Leader:

- (a) Authorised the grant of a new lease to Pro-Active Wellness Centre Ltd, trading as Switch Gyms, (a gym), at Unit G for a term of 2 year.
- (b) Authorised the Solicitor to the Council to conclude the transactions above on the terms outlined below, and on any such other terms and conditions as the Solicitor to the Council may recommend to protect the Council's position.

Proposal for a Rentplus (Rent to Buy) Pilot scheme

The Cabinet Member for Housing and Planning approved the decision that 8 affordable housing units on the Shirley Cottage, 17 Copthorne Road, Felbridge, East Grinstead site become a "Rent to Buy" project through Rentplus.



Proposed Grant of Lease of Lindfield Common Bowling Pavilion, Backwoods Lane, Lindfield, West Sussex

The Deputy Leader authorised the grant of a lease of the Lindfield Bowling Club Pavilion in Lindfield and on such other terms and conditions as the Solicitor and Head of Regulatory Services to the Council may recommend to protect the Council's position.

Lease Renewal of 23 St Wilfrid's Way, The Orchards Shopping Centre, Haywards Heath (EXEMPT)

The Deputy Leader:

- a) Authorised the grant of the lease to YMCA Downlink Group for a term of not more than 5 years on similar terms as the current leases at the Orchards
- b) Authorised the Solicitors acting for the Council, Messrs Russell Cooke, to conclude the transaction above on the terms outlined below, and on any such other terms and conditions as the Solicitor may recommend to protect the Council's position.

<u>Release of Section 106 funds for playground improvement works at Turners Hill Recreation</u> <u>Ground</u>

The Cabinet Member for Environment and Service Delivery authorised the release of £11,934 Section 106 Play and Kickabout Contributions to enable the full improvement of the playground at Turners Hill Recreation Ground to take place.

Information and News

COVID-19 News

Covid levels in Mid Sussex have fallen in the last week to about 350 cases per 100,000 which is around the level we had two weeks ago and therefore remains high and caution is still needed in indoor settings. Hospitalisations locally are rising slowly given the most vulnerable groups are now fully vaccinated and the vaccines prevent serious illness with the current Covid variants. Covid deaths locally remain low.

Covid rates have generally fallen across West Sussex in the last week with an average Covid figure just below the England average of about 430 cases per 100,000. The average Covid rate in West Sussex remains above the South East average of about 350 cases per 100,000.

In many areas of the country Covid rates are still above 400 cases per 100,000 with the Delta variant now being dominant across all of England. That Covid level is found commonly in the NE, NW and parts of the Midlands.

Lateral flow tests are available free to collect locally or request online by post so everyone can check their Covid status and take a PCR test if the lateral flow test indicates a Covid positive result. People are required to self- isolate if they have a positive test or are asked to do so by Test and Trace if they



have been in recent close contact with someone who goes on to test positive for Covid. There are now limited exceptions to this for designated essential workers.

The fourth stage of the roadmap started on Monday 19th July 2021. Most restrictions are lifted but the population is asked to remain cautious given the still high Covid rates. Advice has been issued for various settings and this guidance is similar to the previous restrictions. People are advised to use face masks in crowded indoor settings which includes busy trains and buses and shops. Some transport operators and some supermarkets require masks to still be used.

About 71% of the adult population in England and in Mid Sussex are now double vaccinated and about 88% have received a first vaccination and all adults are now eligible to book a vaccination jab with the second vaccinations being done after 8 weeks. This vaccination programme is being relied on to keep hospitalisations and deaths down despite the still high Covid cases across most of England. First vaccinations per day have fallen this month across England and efforts are being made to get all unvaccinated adults to come forward for their first vaccination with a lot of convenient local pop up vaccination points.
