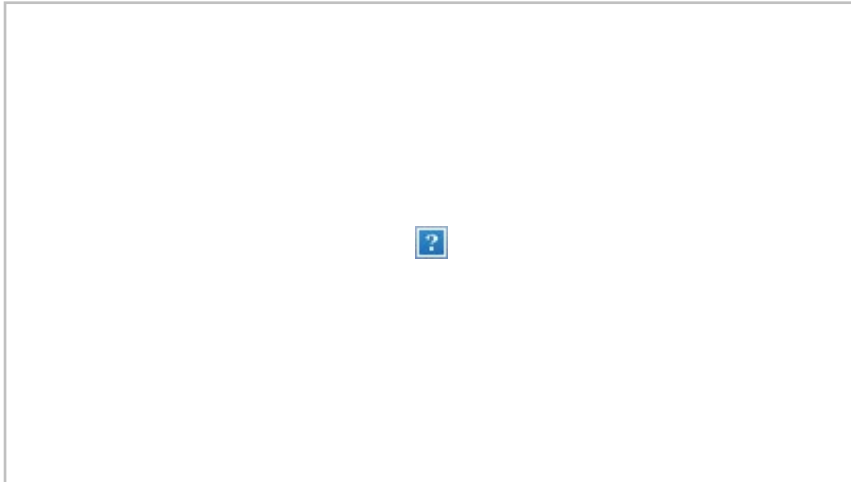

We would like to put in a representation against the proposed new license at The Carriage in Crawley Down.

The proposed closing time of 23:30 on Friday nights, Saturday nights and bank holidays would cause a considerable amount of noise emanating from the establishment especially in the warm weather when the outside areas are in use and we have our window's open. Having people gathered outside number 12 old station close (a cocktail bar) gone 22:00 every Friday and Saturday night just isnt taking into account the nearby residents home lifes, when did the last cocktail bar open in a residential close ?

The current hours of operation are all ready causing us a considerable amount of stress, the establishment is rarely closed at 22:30 on Thursdays, Fridays and Saturdays. We are currently suffering from noise of cars/taxi coming and going, drunken noise of customers when they are `on or off the premises` this will only get worse and drag into the early hours of the morning if the new license get approved.
