COVID-19 News

Covid levels in Mid Sussex continued to fall over the last week to about 140 cases per 100,000 which is around the level we had in late-June 2021 and therefore remain high and caution is still needed in indoor settings. Hospitalisations locally and nationally are higher than in June 2021 but have levelled off in the last week and deaths from Covid nationally still average over 100 per day. The highest rates of Covid are in the school age population where regular testing is happening.

Average Covid rates across West Sussex have fallen to about 180 cases per 100,000 with all areas of West Sussex are below 250 cases per 100,000. The average Covid figure in England is now below 280 cases per 100,000. The average Covid rate in the South East is now below 230 cases per 100,000.

In most areas of England Covid rates are below 400 cases per 100,000. Rates in Scotland, Northern Ireland and Wales have fallen in the past week, but most areas still have rates above 400 cases per 100,000 which is putting pressure on the NHS.

Lateral flow tests are available free to collect locally or request online by post so everyone can check their Covid status and take a PCR test if the lateral flow test indicates a Covid positive result.

People who are not double vaccinated are still required to self- isolate if they are asked to do so by Test and Trace or if they have been in recent close contact with someone who goes on to test positive for Covid. Those double vaccinated or under 18 are recommended to get a free PCR test in these circumstances but need only self- isolate if that test is positive.

About 82% of the population 16 and over in England and in Mid Sussex are now double vaccinated and about 88% of the population 16 and over have received a first vaccination.

All people 16 and over are still eligible for a Covid vaccination jab and encouraged to come forward with the second vaccinations being done after 8 weeks.

Covid vaccinations for all those aged between 12 and 15 are now available and contact is being made directly with those affected. These vaccinations are likely to be done in a school setting.

Booster vaccinations are now being offered to those in the first 9 groups previously getting their second vaccination between March and June 2021, with the booster vaccination to be given about 6 months after the second vaccination was given.

Annual flu vaccinations are now being offered through GP contact to the usual older and vulnerable groups.

New Political Map for Mid Sussex District Council

The Local Government Boundary Commission wants to hear what residents, and other stakeholders think about the proposed new ward boundaries for Mid Sussex District Council. A 10-week consultation on the proposals will run until 8 November 2021.

The Commission is the independent body that draws these boundaries. It is reviewing Mid Sussex to make sure councillors will represent about the same number of electors, and that ward arrangements will help the council work effectively.

The Commission has published proposed changes to Mid Sussex District Council. It is proposing that there should be 25 wards with five one-councillor wards, 17 two-councillor wards, and three three-councillor wards. 23 wards will have their boundaries changed, with three wards (Burgess Hill Franklands, Burgess Hill St Andrews and Copthorne) remaining the same. Members may wish to read the Commission's full report.

The Local Government Boundary Commission for England is an independent body accountable to Parliament. It recommends fair electoral and boundary arrangements for local authorities in England. In doing so, it aims to:

- Make sure that, within an authority, each councillor represents a similar number of electors
- Create boundaries that are appropriate, and reflect community ties and identities
- Deliver reviews informed by local needs, views, and circumstances
