To be clear, the Premises Licence that is currently granted to the premises is not under consideration. This Licence remains in existence and is not affected by the application under consideration. The issues surrounding the current licence is a matter strictly between the pertinent

parties and not a matter for the Licensing Authorities involvement unless particular issues affect either the promotion of the 'Licensing Objectives' or impacts on the requirements of the Licensing Act 2003.

- > The application currently being considered is solely for the grant of a new Premises Licence for the current Leaseholder.
