Information and News

COVID-19 News

Covid levels in Mid Sussex have steadied at about 1500 cases per 100,000 in the last week with the very infectious Omicron variant now accounting for almost all Covid cases. The cases are across all age groups. These high Covid case levels mean caution is needed in indoor settings which should be well ventilated. Hospitalisations of people testing positive for Covid locally and nationally have continued to rise in the last week across the whole of the UK but remain just over half of where they were in January 2021. Positivity rates among those tested are now above 25% in most areas of Sussex. Deaths nationally, within 28 days of a positive Covid test, now average over 150 per day but the rise in deaths has been slower than the rise in cases. Most people in hospital are not fully vaccinated.

The average Covid rate across West Sussex has steadied in the last week at about 1350 cases per 100,000 and remains just below the SE rate of about 1450 cases per 100,000. The Omicron variant hit London earlier than in other parts of the country and in London case levels have dropped in the last week but remain high.

The average Covid figure in England has increased in the last week to about 1700 cases per 100,000 with the more infectious Omicron variant now accounting for almost all Covid cases across the country. The NE and NW of England have the highest infection levels in England with many areas there having over 2000 cases per 100,000. People are recommended to be very cautious in all indoor settings where there is household mixing.

In nearly all areas of the UK Covid rates are above 1000 cases per 100,000.

Lateral flow tests are available free to collect locally or request online by post so everyone can check their Covid status and isolate if they get a positive test. Demand for these tests is high at the moment. If going to crowded indoor settings, you are advised to do a lateral flow test.

With the more infectious Omicron variant of Covid, mask wearing is now compulsory in shops, theatres, indoor halls, churches and museums and public transport which includes taxis and private hire vehicles and in secondary schools. If returning from abroad fully vaccinated, you are required to pay for a Lateral Flow test within 2 days of your return and if positive isolate until you get a negative result. If you are identified as a close contact of someone who has tested positive for the Omicron variant you are required to do a lateral flow tests daily for 7 days if you have had at least 2 vaccinations for Covid. Those that are not double vaccinated still have to isolate for 10 days and get a PCR test.

About 82% of the population 12 and over in England and in Mid Sussex are now double vaccinated and about 88% of the population 12 and over have received a first vaccination. All people 16 and over are still eligible for a Covid vaccination jab and encouraged to come forward with the second vaccinations being done after 8 weeks. Vaccinations can now be booked online for anyone 16 or over. There is a separate online booking system for those aged between 12 and 15 to get their first or second vaccinations outside a school setting at some vaccination locations. Second vaccinations are advised after 3 months from the first vaccination. Otherwise Covid vaccinations for all those aged between 12 and 15 are being done again in some secondary schools.

Booster vaccinations are being offered to all adults 3 months after the second vaccination on the booking system with slots now available. New walk-in clinics are being opened where an appointment is not necessary. About 68% of the population 12 and over have now received their booster vaccination in Mid Sussex and England more generally. Having the booster vaccination is thought to provide



greater protection against all the Covid variants and to reduce the chance of spreading the virus.

Annual flu vaccinations continue to be offered through GP contact to older adults and vulnerable groups.

West Sussex Fire & Rescue Service has launched a public consultation around our proposals for our Community Risk Management Plan 2022 – 2026.

This document sets out the direction of the service over the next four years, and as part of this we have six proposals that we are seeking feedback on.

- Enhancing our retained (on-call) operating model

- How WSFRS should deal with false alarms from automatic fire systems
- When we should review our Emergency Response Standards
- How WSFRS proposes to undertake a review of our specialist appliance requirements to consider current and future risks to firefighter and public safety

This is a key opportunity for our communities and all partners to have their say on our proposals, and we will assess all of the responses and use to inform our final CRMP which we intend to publish in spring 2022.

Protect and Vaccinate

The Government has awarded Mid Sussex District Council £102k to accommodate rough sleepers until the end of March and £13k to incentivise them into having the vaccination.

We are working with Turning Tides, our assertive outreach team, to contact all the rough sleepers in this District. During the pandemic we have helped 53 rough sleepers however, at the last count we were aware of 6 people sleeping rough in the District. We are in contact with them and will continue to encourage them to take our offers of accommodation and to get vaccinated.

LGA National Census of Local Authority Councillors 2022

Members are advised that in January the LGA will be inviting all local authority councillors to take part in its 'National Census of Councillors', last conducted in 2018 (results can be found here). Their questions are largely unchanged, although they have removed some, and added new questions focusing on areas that LGA has heard are of interest to councillors, specifically councillor safety. The results will help the LGA better understand the types of support needed by elected representatives. The LGA will publish a report of the census findings in spring 2022. Response permitting, they will also produce a summary of results for each council.
