Purpose of Report

1. Authority is sought for the Release of S106 contributions to Turners Hill Parish Council to carry out further improvements to The Ark community building, Mount Lane. Turners Hill.

Recommendations

2. It is recommended that £14,294.26 is released to Turners Hill Parish Council from S106 contributions arising from developments at Land at Clockfield (ref: 11/01332/OUT) and Land known as Sopers Ride (DM/18/4540).

Background

- 3. Turners Hill Parish Council leases The Ark from the Council and has some responsibility for maintenance and repairs. The Parish Council is currently in receipt of £37,757.82 in s106 funds to provide additional toilets and storage, upgrade the showers (completed), install new bollard lighting and create some additional car parking space.
- 4. The Parish Council would like to release further s106 receipts to enable them to carry out some more improvements as part of the modernisation works. They are seeking £14,294.26 toward increased costs for the additional car parking based on a revised quote (£5,622), hand driers and flooring in the new toilets (£3,122.26), a door entry system (£2,070) and CCTV (£3,480).
- 5. Unfortunately, the contractor who initially quoted for the additional parking spaces was unable to carry out the work so the Parish Council secured alternative quotes. The total cost of the proposed works is now £9,910 which is more than the original estimate but the quote is not exactly like for like as the new contractor will install timber edging which was not previously included and will provide a better finish.
- 6. The eight new toilets will be completed with the installation of new hand driers and flooring.
- 7. The new intercom and door entry system will offer greater security which is particularly important for evening bookings with individual clients using the foot clinic and osteopath services for example. The system will consist of a 3-button vandal resistant intercom panel, a keypad and three internal handsets which will provide access for staff and authorised users.

- 8. Over the past couple of years, the amount of anti-social behaviour around The Ark has increased. There have been a couple of attempted break-ins and there is evidence of drug use around the building. The new CCTV system will act as a deterrent to this behaviour to make the community in the area feel safer and footage can be shared with the Police if necessary.
- 9. The IP CCTV system will consist of an eight channel 4TB hard drive Network Video Recorder and six static IP CCTV cameras situated around the building. An HDMI monitor will also be installed to enable the camera images to be viewed locally. Turners Hill can be dark and quiet in the evenings and Police presence is limited. CCTV will help to keep the village a safe place to live, while also increasing safety and security for people visiting The Ark late in the evenings.

Financial Implications

10. This project is considered to represent an appropriate expenditure of s106 contributions from the agreement below:
