To consider the consultation responses in respect of the introduction of a new range of flexible season tickets and to proceed with those proposed changes from 28 March 2022.

To confirm the decision to proceed with the introduction of Pay and Display tariff increases and the introduction of a new range of flexible season tickets from 28 March 2022.

Date of decision: 25 January 2022

Statement of reasons for making the decision:

In December 2021, Council agreed, subject to statutory consultation, to implement an increase to Pay and Display parking charges and to introduce a new range of flexible season tickets from March 2022.

Following the decision, the legal process to amend the Off Street Parking Places Order commenced, with the advertising of a Notice of Variation of Charges for the increase of Pay and Display charges (to be displayed for at least 21 days), and a Notice of Amendment for the introduction of new season tickets (which required a 21 day formal consultation period). The consultation period concluded on 14 January 2022, and all the responses submitted have been considered.

A total of 4 responses were received, of which 2 were in response to the consultation for the proposed changes to season tickets and were supportive of the proposals, therefore there is no reason to amend the proposals to change the season ticket offer.

3 responses were received on the notification of a price increase to parking charges. The comments are noted but the volume and nature of the responses is not

considered to be sufficiently substantial to support a change to the proposals.

Alternative options considered and rejected:

The decision to implement an increase to Pay and Display parking charges and to introduce a new range of flexible season tickets from March 2022 was agreed at Council in December 2020.

Following the completion of the statutory legal process, the proposals to amend the season ticket offer have been supported and will be implemented. The comments in regard to the increase in parking charges have been noted.

Therefore, no alternative options have been considered or discounted, as the volume and nature of comments received have not been sufficiently substantial to change the Council decision.

Summary

1. In December 2021, the Council agreed to increase Pay and Display parking charges and introduce a new range of flexible season tickets in Mid Sussex from 28 March 2022.

- 2. Following this decision, the Council is required to amend the Off-Street Parking Places Order, and to issue a Notice of Amendment for the introduction of new season tickets.
- 3. Increases in parking charges require public notification and changes to season tickets require public consultation, as outlined in paragraph 4. This report summarises the responses to the notification and consultation.
- 4. The legal process to update the Off Street Parking Places Order to support the proposed changes is considered in two parts:
 - a. Notice of Amendment: Where the order is being amended to include a new product / restriction / change of wording to the Order that may impact the car park and requires a consultation period of 21 days. This applies to the introduction of the new season ticket proposals.
 - b. **Notice of Variation of Charges:** Where charges are changed in the Order for some or all car parks and requires a 21 day notice period before those charges can be made. There is no requirement to consult. This applies to the proposed increase to pay and display charges.

Recommendations

- 5. To consider the consultation responses in respect of the introduction of a new range of flexible season tickets and to proceed with those proposed changes from 28 March 2022.
- 6. To confirm the decision to proceed with the introduction of Pay and Display tariff increases and the introduction of a new range of flexible season tickets from 28 March 2022.

Background

7. On 8 December 2021, Council agreed, subject to statutory consultation, to implement an increase to Pay and Display parking charges and to introduce a range of flexible season tickets in Mid Sussex from 28 March 2022.

- 8. Following this decision, Officers began the legal processes to amend the Off-Street Parking Places Order, including advertising a Notice of Variation of Charges for the increase of Pay and Display charges (to be displayed for at least 21 days), and a Notice of Amendment for the introduction of new season tickets (which required a 21 day formal consultation period).
- 9. In line with legislation, the Notice of Variation of Charges and Notice of Amendment were advertised in the local newspapers from 16 December 2021, signage was placed in each car park and the proposals were advertised on the Council's website. With an allowance for Christmas, the 21 day consultation period concluded on 14 January 2022.

Summary of responses

- 10. Four responses were received. These are summarised at Appendix 1.
- 11. Two of these were in response to the consultation on the proposed changes to the season tickets both of which supported the introduction of new season ticket options and therefore, there is no reason to amend the proposals to introduce a range of new season ticket options.
- 12. Three of the four submissions commented on the proposed increases to the pay and display charges. In general, the comments acknowledged the financial pressures faced by this Council, and Councils more generally, but suggested that an increase in tariffs could discourage drivers from using the car parks and impact high street footfall, specifically in Burgess Hill where the high street offer was not strong.
- 13. These comments are noted but the volume and nature of responses is not considered to be sufficiently substantial to support any changes to the proposals

Financial Implications

14. The report to Council on 8 December 2021, highlighted a potential income uplift of £350k as a result of introducing new Pay and Display charges and season tickets. This consultation has not resulted in any further financial implications.

Equalities Assessment

15. An Equalities Impact Assessment has been completed for this project, which was appended to the Cabinet report of 18 November 2021. The comments and responses to the consultation do not change the impacts to users of the service.
