Platinum Jubilee Grants Scheme

The Cabinet Grants Panel agreed:

- 1. That a Platinum Jubilee Grant of £845 be released to Ansty Village Centre Trust to fund a celebration on the Ansty Village Recreation ground with food and entertainment.
- 2. That a Platinum Jubilee Grant of £450 be released to Ardingly Connected Together to contribute towards a whole programme of events including lighting of beacon, barbecue, music, firework display and street party.
- 3. That a Platinum Jubilee Grant of £500 be released to Befriended to fund a street party at Court Bushes Community Hub in Hurstpierpoint including a Tea Dance.
- 4. That a Platinum Jubilee Grant of £500 be released to Bentswood Community Partnership to fund a community celebration on Barn Cottage Green including picnic, dancing, face painting and an evening barbecue and bar.

COVID-19 News

Covid is now endemic, and we are working to live with it. Covid rates in West Sussex have come down in the last week and now average about 500 cases per 1000,000. The fall in cases is slowest among older age groups who are more likely to get seriously ill with Covid. With Covid rates still high and the number of people in hospital with Covid at the high levels found at the beginning of the year everyone is asked to remain cautious in busy indoor areas where ventilation is important. Mask wearing in busy indoor settings is still advised.

Those with Covid symptoms are asked to self-isolate until those symptoms have passed to safeguard others. Covid deaths within 28 days of a positive Covid test are up to an average of about 230 per day. Lateral Flow tests will indicate when you are most infectious with Covid and remain free in medical and care home settings.

The best way to avoid serious illness from a Covid infection is to maintain the benefits of vaccination. Those over 75 and Covid vulnerable adults are now being called forward for a second booster vaccination 6 months after their first booster vaccination with online bookings and some drop in centres including at Clair Hall. Covid vaccinations are also now available for 5 to 11 year olds to help reduce the spread of Covid in the community. In West Sussex about 10% of the population aged 12 and over remain without any Covid vaccinations and those people continue to be encouraged to come forward given they make up a large % of the people in hospital seriously ill with Covid. Being fully vaccinated makes overseas travel more straightforward and reduces the need for privately sourced Covid tests as part of the travel requirements.
