## Information and News

### Report from Health Panel Meeting – 27th February 2013

**Attendance :** Cllrs Jones (Chair), Snowling, Moore, Belsey, Webster, Hatton

The Health Panel invited Chris Adcock, Chief Executive of Brighton and Sussex University Hospital NHS Trust (BSUH) to attend the meeting to discuss recent correspondence relating to Accident and Emergency Services.

The Health Panel raised the issue of the capacity of the Accident and Emergency service (A&E) at the Royal Sussex County Hospital (RSCH) at Brighton and the concern that Mid Sussex residents are being transferred to Brighton when they could be seen at A&E at the Princess Royal Hospital (PRH) in Haywards Heath.

Chris Adcock reminded Members that BSUH is one hospital operating on two sites. He admitted that it is challenging time at Brighton with the RSCH operating above capacity and PRH being used as a 'release valve' for Brighton. He assured members that the PRH is fully utilised and confirmed that residents should not be being sent to RSCH if they can be seen at PRH.

Members were reassured that patients are only transferred on clinical judgement and that the hospital is committed to treating patients in the right place.

Chris Adcock said that the hospitals in Sussex are starting to work together more closely and are asking themselves the question 'would we be doing something different if we were one organisation?'

The Health Panel drew Chris Adcock's attention to the fact that there are underused primary care facilities within the District. He reassured Members that BSUH is working closely with the Clinical Commissioning Groups and that there are great opportunities to utilise community and hospital resources more effectively and to improve communication through investment in IT facilities.

Chris Adcock informed the Health Panel that there is quality investment in radiotherapy equipment and satellite services in Eastbourne and there are plans (finances permitting) to have a new cancer centre in Brighton within the next ten years.

Chris Adcock will be stepping down as interim Chief Executive for BSUH at the end of March 2013.

The Health Panel requested that the new Chief Executive, Matthew Kershaw, be invited to a meeting with them at an early stage after he has taken up his appointment.
