COVID-19 News

Covid is now endemic, and we are working to live with it. Covid rates in West Sussex are steadily falling and now average about 80 cases per 100,000. With the average death rate of those testing positive for Covid within 28 days of death down in the last week but still about 100 per day, people are still advised to remain cautious in busy indoor areas where ventilation is important. Mask wearing in busy indoor settings is still advised together with regular handwashing. The number of people in hospital with Covid is now down to about ¼ of the peak numbers in January 2022 and about where they were in Autumn 2021.



Those with Covid symptoms are asked to self-isolate until those symptoms have passed to safeguard others. Lateral Flow tests will indicate when you are most infectious with Covid.

The best way to avoid serious illness from a Covid infection is to maintain the benefits of vaccination. Everyone 5 and over is eligible for a Covid vaccination. Those over 75 and Covid vulnerable adults who have had the second booster vaccination are showing additional protection against Covid infection.

In West Sussex about 10% of the population 12 and over remains without any Covid vaccinations and those people continue to be encouraged to come forward to get their first vaccination.

Being fully vaccinated makes overseas travel more straightforward and reduces the need for privately sourced Covid tests as part of overseas travel requirements.

£150 Council Tax Energy Rebate Update

Where are we?

We are pleased to report to Members that to date we have paid 72% of residents that are eligible for this payment. This is comparable to neighbouring authorities and equates to over 28,000 households and over £4,000,000. We are however aware that some residents have not found the process easy.

What are we doing?

For those residents who pay their Council Tax by Direct Debit, payments should be made automatically by 31st May 2022.

If we are not able to do this automatically, we will write to the resident explaining the steps they will need to take to receive their rebate. This can be the case where the direct debit name does not match the Council Tax liable party.

What if residents do not pay by Direct Debit?

Residents who do not pay by direct debit are required to make a claim for their £150 Council Tax energy rebate. For those who are able, the easiest and quickest way to apply is online at www.midsussex.gov.uk/energy-payments. We would encourage all Members to refer residents to the website. The website includes all information needed to make an application as well as other useful information.

For residents who are not able to make their application themselves online and do not have anyone that can help them they can request a paper application form by calling (01444) 477564 or by visiting reception to collect their form.

We hope to be able to offer telephone applications in the near future and will update Members again once this service is offered.

What can I do as a Councillor to help?

Our phone lines are currently extremely busy whilst we process the applications and help those who have had problems. For anyone who is digitally enabled or who has friends or relatives who can assist, residents should be encouraged to find answers to their questions and apply online at www.midsussex.gov.uk/energy-payments.

For those who do not pay by direct debit, or where there is an issue, we are in the process of writing to and inviting them to make an application. These letters are being sent gradually so that our phone lines are not overwhelmed, which enables residents to be helped quickly, and enables the team to continue answering day to day Council Tax enquiries. However, Members can advise residents there is no need to wait for a letter before going online to make an application.

What happens next?

Once the application is received, we must perform checks to ensure that we are paying the correct person for the correct property. Some of the applications only need an automatic check and payments can be received within a week. Others need more manual intervention and can take longer. Those who apply online will receive an email notification if we need evidence to verify information, and when the applications have been approved.

For those who make a paper application, if further information is required, this will be requested by post, or by telephone, this may also be the case where applications are taken over the phone.



What help is there for low-income families that do not qualify for the main scheme?

We are also processing claims for our local scheme which is currently limited to households in Council Tax bands E-H and are in receipt of Council Tax Support. All those who are eligible have been written to requesting that they make an application.

This is a limited fund, and we want to ensure that we assist the most financially vulnerable residents first. Once these applications have all been received and processed, we will be opening the scheme to all residents in Council Tax bands E-H who are in receipt of any means tested benefits.
