COVID-19 News

Covid is now endemic and we are working to live with it. Covid rates in West Sussex and across the UK are rising significantly. The West Sussex rate now averages about 110 cases per 100,000.



People are advised to remain cautious in busy indoor areas where ventilation is important. Mask wearing in busy indoor settings is also still advised (and now mandatory again in all NHS settings) together with regular handwashing.

The number of people in hospital positive for Covid in the UK is now above 11,000 again. Deaths within 28 days of a positive Covid test are steady at about 50 cases per day in the UK.

Those with Covid symptoms are asked to self- isolate until those symptoms have passed to safeguard others. Lateral Flow tests will indicate when you are most infectious with Covid.

The best way to avoid serious illness from a Covid infection is to maintain the benefits of vaccination. Everyone aged 5 and over is eligible for a Covid vaccination. Booster vaccinations are available for all those aged 50 years plus or otherwise vulnerable. These booster vaccinations are now being done at Clair Hall and across West Sussex. They can be booked online or at some places a walk in service is available. Flu vaccinations are also underway.

In West Sussex about 6% of the population aged 12 and over remain without any Covid vaccinations and those people continue to be encouraged to come forward to get their first vaccination.

Flu vaccination: who should have it this winter and why update

The UK Health Security Agency has today (18 October) updated guidance that explains the importance of the influenza (flu) vaccination this winter: 2022 to 2023. The update includes order links to the English, Braille and large print versions of guidance, which explains to patients how they can help protect themselves and their children against flu this winter.

The document also has information for children, eligible adults and pregnant women, and details why it's important that people at increased risk from flu, or who care for someone vulnerable, to have their free vaccination every year.

Veterans' Survey

The Office for Veterans' Affairs and the Office for National Statistics will be launching the Veterans' Survey this Autumn. This is the first ever exercise to collect feedback from the veteran's community across the UK.

The online survey will be launched in November and will be live for 12 weeks, giving ex-UK Armed Forces personnel and their families the opportunity to provide direct feedback to the government on their experiences, access to and use of services for veterans.

Responses to the survey will help the government better understand the experiences, needs and wellbeing of the veteran community, and to guide future action.

The government is looking for a wide range of views and would like to encourage as many ex-UK Armed Forces veterans and their families to share feedback.

Strike Dates Affecting Royal Mail Services

The Communication Workers Union (CWU) has issued formal notification to Royal Mail of network-wide industrial action on Thursday 20th and Tuesday 25th October 2022. Members who are registered to receive Council and Committee papers in hard copy can therefore expect that delivery of these mailings will be severely delayed.

The papers for <u>Council</u> (<u>2 November</u>) are lengthy and <u>will be published online on Tuesday 25th <u>October</u>. You can read them at the Council's website – the link is provided within the publication email that you receive – and the papers may also be accessed via the Mod.Gov App for those who are using that system.</u>

Hard copy Council papers will be dispatched first class on Wednesday 26th October, that being the earliest date that we can receive these large bundles from our printer. Clearly, we cannot assume that these will be delivered in a timely manner owing to potential backlogs that might exist in the Royal Mail network. <u>Information on Building Control Services</u>

This month a link to a website called Front Door has been added to colleagues' signatures in development management and building control. The website is for homeowners, providing practical guidance on all sorts of home improvements and renovations as well as technical advice on obtaining building control and planning approvals. Front door is a Local Authority Building Control (LABC) website, who are a not-for-profit membership organisation that represents all local authority building control teams in England and Wales.



Low Carbon Business Videos

The West Sussex local authorities are progressing a joint programme to support businesses to lower their carbon footprint, with funding agreed from the pooled business rates Economic Recovery Fund.

A key part of the programme is the delivery of a 'Low Carbon Business' video series, telling the story of exemplary businesses from across the county who have embraced sustainability to realise tangible business benefits. Businesses from across sectors, and representing each District and Borough feature in the series, hosted on the <u>WSCC YouTube channel</u>.

The series recognises that with raised awareness on climate change, there's an increased need for businesses to act if they are to remain competitive as the economy shifts to low carbon. Smaller businesses have a vital role to play in reducing collective carbon emissions. 99.6% of West Sussex business are micro, small or medium sized enterprises (MSMEs), however recent research has found that more than 75% of UK MSMEs do not yet have carbon reduction plans in place.
