Cabinet Grants Decisions – 24 October 2022

The following decisions have been made by the Cabinet Grants Panel at their meeting held on Monday 24 October 2022 and will come into effect at 10.00 a.m. on Thursday 3 November 2022 unless the call-in procedure is activated. Corporate Grants Scheme - Release of S106 contributions

The Cabinet Grants Panel agreed:

- 1. That £10,863 of S106 Contributions be released to Ashenground Community Centre to fund the purchase and installation of an Audio-Visual System to provide a low-cost Community Cinema.
- 2. That an additional £10,000 of S106 Contributions be released to Haywards Heath Tennis Club to enable the organization to deal with inflationary pressures and ensure delivery of their project to refurbish their clubhouse.

Corporate Grants Scheme - Community Grants

The Cabinet Grants Panel agreed:

- 1. That £1,716.22 from the Community Grants Fund be released to 4Sight Vision Support to fund the production of newsletters in accessible format.
- 2. That £9,500 from the Community Grants Fund be released to Carers Support West Sussex to fund a project to identify and engage with male carers in Mid Sussex.
- 3. That £820 from the Community Grants Fund be released to Family Support Work to fund the setup of an informal, drop-in group for isolated parents and carers of children at the Bentswood Hub.

Microbusiness Grant Scheme

The Cabinet Grants Panel agreed:

1. That a Microbusiness Grant of £1,500 be awarded to Angie's Nails and Beauty to fund the purchase of cleaning equipment.



- 2. That a Microbusiness Grant of £2,000 be awarded to Men do Pilates to support the development of new products.
- 3. That a Microbusiness Grant of £908 be awarded to Sussex Facilities Management Ltd to fund the purchase of a new heat sealer for product packaging.
- 4. That a Microbusiness Grant of £1,833 be awarded to Cerowski Architects Ltd to fund the purchase of staff training and registration for solar panel installations.
- 5. That a Microbusiness Grant of £1,360 be awarded to Seasons Art Class Haywards Heath to fund the hire of an apprentice.
- 6. That a Microbusiness Grant of £2,000 be awarded to Ouh La La to fund the hire of an apprentice.
- 7. That a Microbusiness Grant of £499 be awarded to Clearthink Counselling to fund the hire of an apprentice.
- 8. That **no** Microbusiness Grant be awarded to Pera Midtown as they had not submitted the required information in time for the Panel.

Information and News

COVID-19 News

Covid is now endemic, and we are working to live with it. Covid rates in West Sussex and across the UK have steadied after rising through most of October. The West Sussex rate now averages about 110 cases per 100,000.

People are advised to remain cautious in busy indoor areas where ventilation is important. Mask wearing in busy indoor settings is also still advised (and now mandatory again in all NHS settings) together with regular handwashing.

The number of people in hospital positive for Covid in the UK is now about 10,000 and therefore slightly down from the peak this month. Deaths within 28 days of a positive Covid test are now about 60 cases per day in the UK.

Those with Covid symptoms are asked to self-isolate until those symptoms have passed to safeguard others. Lateral Flow tests will indicate when you are most infectious with Covid.

The best way to avoid serious illness from a Covid infection is to maintain the benefits of vaccination. Everyone aged 5 and over is eligible for a Covid vaccination. Booster vaccinations are available for all those aged 50 years plus or otherwise vulnerable. These booster vaccinations are now being done at Clair Hall and across West Sussex. They can be booked online or at some places a walk in service is available.

Flu vaccinations are also well underway with walk ins at Clair Hall and at many pharmacies.

In West Sussex about 6% of the population aged 12 and over remain without any Covid vaccinations and those people continue to be encouraged to come forward to get their first vaccination.

Being fully vaccinated makes overseas travel more straightforward and reduces the need for privately sourced Covid tests as part of some overseas travel requirements.

GATCOM Update – Report from Cllr Stephen Hillier

GATCOM met recently and the following is a brief synopsis of substantive matters:

- Most members of GATCOM had sympathy with claims that GAL (Gatwick Airport Ltd) has not
 provided all of the data that had been requested in relation to proposed noise envelope work. A
 letter detailing concerns from the "Environmental and Amenity Groups" is going to be circulated
 to GATCOM members along with a response from GAL, and from there a decision will be made
 about whether this is something that should be submitted into the Northern Runway expansion
 planning (DCO) process with the government
- Concern was also raised about the number of dispensations granted for night-flights. We heard that actually they are lower this year than pre-covid numbers and only 1:8 requests are agreed to and are often reacting to weather conditions or variations happening in the European Airspace area. This matter is monitored by NaTMAG (Noise & Tracking Monitoring Advisory Group).
- The Department of Transport gave a presentation of their "JetZero" programme which seeks to make the UK aviation industry Net Zero by 2050. CO2 emissions more than doubled between 1990 2019 reaching 38.2MtCO2e. Aviation is expected to become one of the largest residual emitting sectors by 2050. Key problems are the still-early stages of the needed technology and the global nature of the industry, with different nations taking different approaches. We are setting an earlier target of 2040 for UK domestic flights to reach Net Zero. They are at early stages in the consideration of non-CO2 emissions strategy. Progress towards stated target trajectories will commence being monitored annually from 2025
- GAL are still aiming to make their DCO submission Q1 2023. They recently concluded their transport consultation and again there was mention of concerns over the quality of the information and WSCC advised that they had been unable to support the expansion in relation to the traffic study. MSDC's own strong response reflected concerns over the adequacy of their modelling for roads, public transport and parking

Flu vaccination: who should have it this winter and why update

The UK Health Security Agency has today (18 October) updated guidance that explains the importance of the influenza (flu) vaccination this winter: 2022 to 2023. The update includes order links to the English, Braille and large print versions of guidance, which explains to patients how they can help protect themselves and their children against flu this winter.

The document also has information for children, eligible adults and pregnant women, and details why it's important that people at increased risk from flu, or who care for someone vulnerable, to have their free vaccination every year.

Veterans' Survey

The Office for Veterans' Affairs and the Office for National Statistics will be launching the Veterans' Survey this Autumn. This is the first ever exercise to collect feedback from the veteran's community across the UK.

The online survey will be launched in November and will be live for 12 weeks, giving ex-UK Armed Forces personnel and their families the opportunity to provide direct feedback to the government on their experiences, access to and use of services for veterans.



Responses to the survey will help the government better understand the experiences, needs and wellbeing of the veteran community, and to guide future action.

The government is looking for a wide range of views and would like to encourage as many ex-UK Armed Forces veterans and their families to share feedback.

<u>Information on Building Control Services</u>

This month a link to a website called Front Door has been added to colleagues' signatures in development management and building control. The website is for homeowners, providing practical guidance on all sorts of home improvements and renovations as well as technical advice on obtaining building control and planning approvals. Front door is a Local Authority Building Control (LABC) website, who are a not-for-profit membership organisation that represents all local authority building control teams in England and Wales.

Low Carbon Business Videos

The West Sussex local authorities are progressing a joint programme to support businesses to lower their carbon footprint, with funding agreed from the pooled business rates Economic Recovery Fund.

A key part of the programme is the delivery of a 'Low Carbon Business' video series, telling the story of exemplary businesses from across the county who have embraced sustainability to realise tangible business benefits. Businesses from across sectors, and representing each District and Borough feature in the series, hosted on the WSCC YouTube channel.

The series recognises that with raised awareness on climate change, there's an increased need for businesses to act if they are to remain competitive as the economy shifts to low carbon. Smaller businesses have a vital role to play in reducing collective carbon emissions. 99.6% of West Sussex business are micro, small or medium sized enterprises (MSMEs), however recent research has found that more than 75% of UK MSMEs do not yet have carbon reduction plans in place.
