COVID-19 News

Covid is now endemic, and we are working to live with it. Covid rates in West Sussex and across the UK have gradually fallen through most of November. The West Sussex rate now averages about 48 cases per 100,000.

The best way to avoid serious illness from a Covid infection is to maintain the benefits of vaccination. Everyone aged 5 and over is eligible for a Covid vaccination. Booster vaccinations are available for all those aged 50 years plus or otherwise vulnerable. These booster vaccinations are now being done at Clair Hall and across West Sussex. They can be booked online or at some places a walk-in service is available.

Flu vaccinations are also well underway with walk-ins at many pharmacies.

Consultation on the extension of existing Public Spaces Protection Order

MSDC, in partnership with Sussex Police, is consulting on the extension of our existing Public Spaces Protection Order to combat the anti-social use of vehicle activity in Burgess Hill. We are also proposing two new areas where there have been recent incidents of car cruising. The consultation is due to run until 22 December and full details are available at Consultations - Mid Sussex District Council

Warm Home Discount Scheme Reopened

On 14 November, the Department for Business, Energy & Industrial Strategy announced the reopening of the Warm Home Discount scheme which will provide a discount of £150 off electricity bills for three million low-income households this winter. Most households will receive the discount automatically.

The government has launched a new online tool, to make it easier for the public to check if they are eligible for the discount. The online tool will guide customers through the eligibility criteria in England and Wales, asking questions about electricity supply, the benefits they receive and characteristics of their property.

All customers will receive a letter between this month (November) and mid-January 2023 confirming their eligibility and the payment will be made automatically through energy suppliers by March 2023.

The government is also writing to customers who may be eligible, advising them to use the tool linked below to check eligibility, as well as to use the helpline for particularly complex cases.

Veterans' Survey Launched

On 10 November, the government launched the Veterans' Survey, for veterans and their families.

This is the first-ever exercise to collect feedback from the veteran community across the UK, coordinated by the Office for Veterans' Affairs and the Office for National Statistics (ONS). Responses to the survey will help the government better understand the experiences, needs and wellbeing of the veteran community.

The Cabinet Office is encouraging councils to promote the survey and encourage and support veterans to take part. They would like to encourage as many ex-UK Armed Forces veterans and their families to share feedback as possible.

Councils can find a stakeholder toolkit of resources on the ONS website. This includes digital posters; social media assets; FAQs; survey links and suggested social media, newsletter and promotional copy for use on your communications channels. These can be adapted as needed for your audience and channel requirements.
