Cabinet Grants Panel decisions –

Micro Business Grants

- 1. That a Microbusiness Grant of £1,800 be granted to Fine Baps to fund the introduction of a delivery service which requires kitting out the business van, equipment and marketing for the new service.
- 2. That a Microbusiness Grant of £2,090 be granted to Fun Pots to fund market research, the offer of a new service, an increase to staff hours and to employ an apprentice.
