Storefront Grant Scheme

1. That, subject to available funding, a Storefront Improvement Grant of £4,000 be awarded to Flinders Coffee to fund the replacement of the existing door and surround along with new signage to improve external storefront look.
2. That, subject to available funding, a Storefront Improvement Grant of £4,000 be awarded to Upmarket22 to fund the renovation of the new storefront following a move of the store.

1. That a Community and Economic Development Grant of £1,000 be awarded to Mid Sussex Community Support Association to deliver a drop-in club in Haywards Heath for people with mental health issues.
