Asset of Community Value (Court Meadow School)

The Cabinet Member for Economic Growth and the Cabinet Member for Housing and Planning concluded that, after receipt of a completed community right to bid nomination form from Cuckfield Parish Council in regards to Court Meadow School in Cuckfield, the nominated asset is not a qualifying asset in accordance with the categories set out in the regulations within the District of Mid Sussex and is therefore an unsuccessful nomination.

Release of S.106 Contributions for Sustainable Transport Infrastructure (Ardingly Parish Council)

The Cabinet Member for Housing and Planning authorised the release of £507.50 from the S106 Sustainable Transport (TAD) fund to Ardingly Parish Council to fund the purchase 10 sets of Speed Indicator Device (SID) brackets.

Release of S.106 Contributions for Sustainable Transport Infrastructure (EG Felbridge Junction)

The Cabinet Member for Housing and Planning authorised the release of £7,500 from the Sustainable Transport (TAD) fund to contribute to the preparation of a jointly commissioned options appraisal of Felbridge junction, in East Grinstead.
