Statement of reasons for making the decision:

The Council had originally been given £3.020m to pay additional restrictions discretionary grants to businesses within Mid Sussex. The Council has also been given £296,485 to pay local additional restrictions support (open) discretionary grants to businesses within Mid Sussex for the period from the 2nd December 2020 to the 18th December 2020 (17 days). There is also at least a further Tier 2 period from the 19th December 2020 to the 25th December 2020 as well as the Council's share of a £500m additional discretionary grant funding for the 3rd national lockdown from the 5th January 2021. The maximum amounts for the respective grants have also been increased to help local businesses at this challenging time. Purpose of Report

 To seek further approval for the Council's Additional Restrictions and Local Restrictions Support (Open) Discretionary Grant to local businesses guidelines following the announcement that Mid Sussex DC will be in a national lockdown from the 5th January 2021.

Summary

2. The Council had originally been given £3.020m to pay additional restrictions discretionary grants to businesses within Mid Sussex. The Council has also been given £296,485 to pay local additional restrictions support (open) discretionary grants to businesses within Mid Sussex for the period from the 2nd December 2020 to the 18th December 2020 (17 days). There is also at least a further Tier 2 period from the 19th December 2020 to the 25th December 2020 as well as the Council's share of a £500m additional discretionary grant funding for the 3rd national lockdown from the 5th January 2021. The maximum amounts for the respective grants have also been increased to help local businesses at this challenging time. These unified guidelines seek to provide guidance to staff, stakeholders and local businesses on how Discretionary Grants are to be made and what factors are considered when making an award.

Recommendations

- 3. The Leader is recommended to:
 - (i) Approve the Council's updated joint Additional Restrictions and Local Restrictions Support (Open) Discretionary Grants Guidelines;

Background

- 4. On the 31st October 2020 the Government announced that it would provide Local Authorities with additional funding to target small businesses with high fixed property-related costs for additional restrictions discretionary grant to offset the impact of the COVID-19 second national lockdown.
- 5. On the 26th November the Government announced the end of the national lockdown with effect from the 2nd December 2020 and the placing of Mid Sussex District in the High Category (Tier 2). Further business grants including discretionary ones are available in tier 2 to qualifying businesses.

- 6. On the 5th January 2021 the Government announced that it would provide Local Authorities with further additional funding to target small businesses with high fixed property-related costs for additional restrictions discretionary grant to offset the impact of the COVID-19 third national lockdown. This was in addition to the further other business grant schemes announced.
- 7. Government guidance for the scheme was issued on the 2nd November 2020. The Government Guidance is at https://www.gov.uk/government/publications/local-restrictions-grant-arg-guidance-for-local-authorities. This guidance the Government has confirmed has not been updated.
- 8. In its guidance, issued initially on the 2nd November 2020, the Government asked Councils to prioritise the following types of businesses in our scheme:
 - businesses which while not legally forced to close that are nonetheless severely impacted by the restrictions put in place to control the spread of COVID19.
 - •This could include for example businesses which supply the retail, hospitality, and leisure sectors, or businesses in the events sector.
 - Local Authorities may also choose to help businesses outside the business rates system, which are effectively forced to close for example market traders.
 - Provide additional support to larger local businesses which are important to the local economy, on top of the funding provided to those businesses via the Local Restrictions Support Grant (Closed) scheme, with due reference to State Aid.
- 9. The scheme also includes the criteria the Government wanted included as well as those we need to address locally within our district at Mid Sussex:-
 - Small businesses in shared offices or other flexible workspaces,
 - Regular market traders with fixed stall locations who do not have their own business rates assessment and have their main domestic residence in Mid Sussex
 - Businesses in the supply chain to the Retail, Leisure and Hospitality or event sectors that do not qualify for the Government's Local Business Support Grants but pay business rates or have other property costs
 - Businesses that do not qualify for additional restrictions or other business grants but pay onerous business rates or have other relatively high property costs. This may include the topping up of any local restriction support granted.
 - Businesses which may have qualified for a local restrictions support grant but are waiting for a business rate valuation decision from the independent Valuation Office Agency.
- 10. Applications for the discretionary scheme are open to businesses outside of the categories listed in paragraphs 8 and 9 above but will only be considered once these priority applications have been processed.

- 11. Following feedback the it has been agreed West Sussex that the maximum amounts available for these discretionary grants will increase. Future payments will now be made to qualifying businesses between £1 and £9,000 depending on the size of business and the extent to which each business has been impacted by COVID19. In exceptional cases a grant of between £1 and £25,000 may be paid.
- 12. A local business can apply for one discretionary grant per funding round. It is at the discretion of the Local Authority such as Mid Sussex if any grant is approved.
- 13. To date on the Business Grants (Small Business Grants Fund and the Retail, Hospitality and Leisure Grants) and the previous Discretionary Grant Scheme the Council has paid out over £27.8m to over 2,350 businesses.
- 14. Mid Sussex District Council has agreed these guidelines with all the other West Sussex Local Authorities (attached as Appendix 1) that largely reflect the previous Discretionary Grant guidelines which was from feedback received from the 3 local business associations in Mid Sussex district was very successfully implemented.
- 15. Local business will apply for one discretionary scheme. Officers will move the grant claim to the relevant Discretionary Grant scheme. Guidelines have also been agreed for the Local Restrictions Support Grant (Open) scheme to assist officers with this. This is attached as Appendix 2.

Next Steps

- 16. The Additional Restrictions Discretionary Grants Fund Scheme went live following previous approved on the 23rd November 2020. If the amended discretionary scheme is approved this will apply for all discretionary grant claims from Funding Round 2 which closed at midnight on the 10th January 2021. An application needs to be made by way of an online application (all bar 2 West Sussex Councils have their online claim at www.grantapproval.co.uk).
- 17. The Council will, in line with all the other West Sussex Local Authorities, close the applications for Funding Round 3 at midnight on the 15th February 2021 to allow time to evaluate the merits of all applications rather than operate on a first come first serve basis.
- 18. Officers are already deciding which applications to approve but will make payments once the updated guidelines are approved. For funding window 3 between the 15th February 2021 and the 22nd February 2021 officers will process the applications and designated senior officers (in consultation with members where appropriate) will decide in line with the guidelines who receives a grant and for how much. We are planning to make payment in the week beginning 1st March 2021. Further funding windows will be displayed on the Council's website.
- 19. Officers will give the Council Leader a weekly update.

Consultation

- 20. Consultation on these amended guidelines was again led by Mid Sussex DC and took place with the following Services across all the West Sussex Local Authorities;
 - Finance Officers
 - Economic Development Officers
 - Communities Officers

- Revenues and Benefit Managers
- 21. All comments from this consultation were acted upon but the feedback on the new Additional Grants Discretionary Grants guidelines has been extremely favourable.

Policy Context

22. Two of the Council's main priorities are Sustainable Economic Growth and Financial Independence. It is important that we provide maximum financial help to help local businesses continue to trade after COVID19. To ensure this we need to adopt guidelines for these additional funding streams that will ensure fairness and that funding from the Government is maximised to help the struggling businesses in our district survive beyond the impact of COVID19.

Other Options Considered

23. The options considered in this report are the only ones available to the Council as the Council seeks to become more transparent in the use of its discretionary financial assistance to local business during the current COVID19 outbreak. These guidelines mirror the previous Discretionary Guidelines, which from independent feedback were successfully introduced and have been agreed by all West Sussex Local Authorities.

Financial Implications

- 24. The government grant allocated by the Department for business energy and industrial strategy (BEIS) in respect of the Additional Restrictions Discretionary Grants is £3.020m, which has now been topped up by £1,341,536 for the third national lockdown from the 5th January 2021 making a total of £4,361,536 for this discretionary grant scheme. The government grant allocated by the Department for business energy and industrial strategy (BEIS) in respect of the Local Restrictions Support (Open) Grants is £296,485. Further funding for these discretionary grants for the period from the 19th December 2020 to the 25th December 2020 whilst in Tier 2 is promised although as yet we do not know our actual allocation. These are cash limited grants and any expenditure incurred over and above this must be funded by the Council, unless there are further periods of national lockdown or Tier 2/3/4 restrictions. There is currently no additional funding identified within the Council to support these Discretionary Grants, which means that expenditure will need to be contained within the cash limited grant.
- 25. The Council will receive New Burdens Funding from the Government for administering the Additional Restrictions Discretionary Grants. The amount is still to be decided but the Council's Business Unit Leader for Revenues and Benefits is a member of the working party looking at this.

Risk Management Implications

26. There is a potential risk to the Council's reputation should any awards of Discretionary Grants payments be applied inconsistently or unfairly or Government funding is unspent locally. However, this risk will be managed by the drafting of robust guidelines that are consistent and that will provide clear guidelines to staff making such decisions on a case by case basis and allow an element of discretion in exceptional circumstances.

Equality and Customer Service Implications

27. These policies do not have a negative effect on any group and has been developed to help support those businesses most disadvantaged by COVID19 that have not already received Government assistance. An equality impact assessment has not been undertaken as we will only help customers who apply for a discretionary grant and we follow clear guidelines issued by BEIS.

WEST SUSSEX DISTRICT COUNCIL's

ADDITIONAL RESTRICTIONS DISCRETIONARY GRANT AND TIER 2/3 LOCAL RESTRICTIONS SUPPORT DISCRETIONARY GRANT GUIDELINES

- 1. The West Sussex local authority Boroughs and Districts utilising these guidelines are:
 - Adur District Council
 - Arun District Council
 - Chichester District Council
 - Crawley Borough Council
 - Horsham District Council
 - Mid Sussex District Council
 - Worthing Borough Council
- 2. This guidance sets out the guidelines under which businesses in West Sussex will qualify to make an application to the Local Authority Additional Restrictions Discretionary Grants and the Tier 2/3 Local Restrictions Grants (Open) Fund (as appropriate), and the evidence required to support an application, and is aligned with the government guidance for the Additional Restrictions Grant and the Local Restrictions Support Grant (Open) both issued on 3rd November 2020 and any revisions at later dates, which can be found via this link:- https://www.gov.uk/government/publications/local-restrictions-support-grants-lrsg-and-additional-restrictions-grant-arg-guidance-for-local-authorities.
- 3. Therefore, for the avoidance of doubt any guidance in the Government Guidance also applies to the scheme(s) operating in West Sussex (unless stated otherwise) and should be referred to as well as these local guidelines.
- 4. The Government suggests that Local Authorities may wish to consider collaborating as they design their discretionary schemes to ensure there is consistency where they are working across a functional economic area. All seven Council's in West Sussex, listed above, have agreed and approved these guidelines, although it is up to each individual Local Authority which grants they approve based upon available resources.
- 5. Individual Local Authorities in West Sussex reserve the right to review the scheme criteria (and whether or not to have one joint scheme open or two separate grant schemes with an individual or joint claim form) to ensure that financial support is going to those most in need (which may involve additional individual local authority guidance), as well as to help businesses who provide employment to others whilst available resources allow.

6. Additional Restrictions Discretionary Grant (ARG) categories

Additional Restriction Grant and Local Restrictions support Grant (Open) funding is a funding payment by the Government to local authorities to be used during 2020/21 and 2021/22 (for Additional Restrictions Grant) to provide support to businesses affected by the COVID19 pandemic. Local authorities are encouraged to provide support to businesses through wider support initiatives, although primarily the support is envisaged to take place in the form of discretionary grant payments

In order to provide an immediate response and emergency support to businesses impacted by the current lockdown the following are confirmed guidelines for distribution of Additional Restrictions and Local Restrictions Support (Open) Grant.

Eligible businesses:

6.1 Businesses who

- Are not entitled to Local Restriction Support Grant (Closed) or Local Restriction Support Grant (Closed Addendum) scheme as they are not responsible for payment of business rates, and
- were open and trading the day before national or local restrictions were imposed for their current claim period, and
- are now required to close under national restrictions (e.g. non-essential market traders, Bed and Breakfast, shared workspace).

6.2 Businesses who

- Are not entitled to Local Restrictions Support Grant (Closed) or Local Restriction Support Grant (Closed Addendum) Scheme as they are not responsible for payment of business rates, and
- were open and trading the day before national or local restrictions were imposed for their current claim period, and
- while not legally forced to close are nonetheless severely impacted by the restrictions put in place to control the spread of COVID19 (e.g. businesses which supply the retail, hospitality, and leisure sectors, or businesses in the events sector).

6.3. Businesses who

- Are not eligible or did not apply under any other grant scheme, for example, may have qualified for Local Restrictions Support Grant (Closed) or Local Restriction Support Grant (Closed Addendum) scheme but are waiting for a business rate valuation decision from the independent Valuation Office Agency or who began trading before or on the 5th November 2020, the 2nd December 2020 or 5th January 2021 (or a later date as applicable to each scheme), and
- Were open and trading the day before national or local restrictions were imposed for their current claim period, and

- Are either required to close or while not legally forced to close are nonetheless severely impacted by the restrictions put in place to control the spread of COVID19 (e.g. businesses which supply the retail, hospitality, and leisure sectors, or businesses in the events sector, markets, Bed and Breakfast, shared workspaces), and
- Are having to pay unavoidable fixed property costs during the period of restrictions
- 6.4 Businesses receiving a mandatory Local Restrictions Support Grant (Closed) or Local Restriction Support Grant (Closed Addendum) can also apply for Additional Restrictions Grant. It is up to the discretion of each Local Authority to issue further grant funding to previous recipients eg taxi drivers in further funding rounds.
- 6.5 If a business ratepayer, then Local Restrictions Support Grant (Support) scheme maximum grant levels for that grant will be applicable. If not a ratepayer Local Authority Additional Restrictions Discretionary Grant criteria applied to determine what would have been applicable under Local Authority Additional Restrictions Discretionary Grant and/or the Tier 2/3 Local Restrictions Grant Support (Open) and grants as detailed in 6.2 and 6.3 above applied. The West Sussex Local Authorities reserve the right to reopen the previous scheme if genuinely missed out due to late start or valuation query.

Exclusions to Additional Restrictions or Local Restrictions Support (Open) Grant funding

- 7. Businesses that have already received grant payments that equal the maximum levels of State aid permitted under the de minimis and the COVID19 Temporary State Aid Framework.
- 8. For the avoidance of doubt, businesses that are in administration, insolvent or where a striking-off notice has been made, are not eligible for funding under this scheme.
- Certain businesses will not be able to apply for an additional restrictions
 discretionary grant or local restrictions support (open) grant. This includes Air BnB,
 due to the limited funding amount available and the shortage of housing available within
 West Sussex.
- 10. Businesses that were not trading on the first full day of the respective funding rounds for this discretionary grant scheme. For the purpose of Funding Round 1 of these grants the first full day is the 5th November 2020 or for Funding Round 2 the date is the 2nd December 2020 or for Funding Round 3 the date is the 5th January 2021 (further dates for further funding rounds will be displayed on West Sussex District Council websites).

Local Eligibility Criteria and Payments

11. Where a business has not been required to close and is affected such as the loss of income by COVID19, then the Councils in West Sussex will consider the fixed costs of

that business, including rent and business rates. Where the business does not pay rent or business rates, then the Council's will consider other unavoidable business related fixed costs, and will be able to estimate the rateable value of the premises that the business is operating from. Fixed costs must normally be in the name of the business applying for a grant.

- 12. Priority will be given to those businesses that, whilst not being required to close, have been affected by the closure of other businesses, and in particular those businesses in the supply chain to those closed businesses. This would include businesses that supply the retail, hospitality and leisure sectors, or businesses in the events sector.
- 13. Any business applying must be operating within the boundaries of the relevant West Sussex Council.
- 14. Local Councils in West Sussex will prioritise businesses and organisations that provide support to local communities within the Local Authority area, and where the restrictions have impacted on their income, that are highly like to flourish after COVID19.
- 15. Councils in West Sussex may also take into account the number of employees and the scale and risk of potential job losses, whether businesses have had to close operations and are unable to trade online, and the consequent scale of impact of COVID19 losses.
- 16. Businesses will be required to demonstrate that they have been severely impacted by the national or local tier restrictions. As well as meeting the criteria it is the intention for the discretionary additional restrictions grants to support local businesses whose intention it is to continue to trade and do business in the local area after COVID19.
- 17. Awards will be made to cover the relevant national or local restriction period, initially four weeks from 5th November 2020 to 1st December 2020 and then six weeks from the 5th January 2021 to the 15th February 2021, in line with grants paid under the Local Restrictions Support Grant Scheme (Closed Addendum). Further awards will be made to cover the Tier 2 Local Restrictions Grant Scheme as appropriate from the 2nd December 2020 to the 25th December 2020 and any subsequent Tier 2, 3 or 4 periods.
- 18. Whilst the payment of grants previously will not exclude a business from applying this may be a factor included when deciding to award a grant and/or the level of any grant. One grant claim can be made per property in any funding round although it is at the discretion of each individual Council to award any grant for each funding window.
- 19. The grant levels and eligibility criteria are presented below (these updated amounts are valid from the Additional Restrictions Grant (ARG) Funding Window 2 from the 14th December 2020:-.

- Businesses occupying a commercial property on the local authority ratings list, with a Rateable Value of over £15,000 and less than £51,000

- If no Rateable Value or rent, then the local authority may estimate the rateable value or rent of the property where the business is based, or take into account other business related fixed costs in the name of the business with a value of over £15,000 and less than £51,000 per annum.
- Unable to trade or must prove severe loss of income.

Up to £6,000 per Additional Restrictions Grant (ARG) funding round.

- Businesses occupying a commercial property on the local authority ratings list, with a Rateable Value of over £51,000 or above
- Where there is no Rateable Value, then businesses paying rent of £51,000 or above per annum
- If no Rateable Value or rent, then the local authority may estimate the rateable value or rent of the property where the business is based, or take into account other business related fixed costs in the name of the business with a value of over £51,000 per annum
- Unable to trade or must prove severe loss of income.
- In exceptional circumstances any local authority in West Sussex may pay above the maximum amounts outlined in the above boxes.
- This is at the discretion of the individual Local Authority.
- Exceptional circumstances is not defined but need to meet as a minimum 2 conditions – severe loss of income and closure.
- Award of exceptional amount grants may be taken into account in the awards of future grants.
- Unable to trade or must prove severe loss of income.

Up to £9,000 per Additional Restrictions Grant (ARG) funding round.

Up to £25,000 per Additional Restrictions Grant (ARG) funding round.

Additional Restrictions Grant Funding Rounds

20. The Additional Restrictions Grant Funding Windows are as follows:-

Round 1 – 16th November 2020 to the 13th December 2020

Round 2 – 14th December 2020 to the 10th January 2021

Round 3 – 11th January 2021 to the 15th February 2021

21. Further Additional Restrictions Grant Funding Windows will be posted on all West Sussex District Council websites.

The Application Process

- 22. The application form will be available online. This electronic form including the declaration must be fully completed with all the required evidence to be considered for a grant.
- 23. Applications can be made in funding windows that will be advertised by the individual Local Authority. Payments in this funding window will be made by BACS before Christmas where possible. A remittance notice will be emailed to accompany any grant payment.
- 24. Further funding windows will be offered for further national or local lockdowns and/or if resources are still available.

Evidence Required for Discretionary Grant Fund application

- 25. In order for an application to be considered, we require businesses to demonstrate that they meet the eligibility criteria stated above. The more meaningful the evidence, the more compelling the grant application will be. We anticipate that to do this, applicants will need to provide as a minimum:
 - Evidence that the property is closed, or partially closed (e.g. a retail premise trading as click and collect only).
 - Proof of identity of sole trader or limited company
 - Evidence of unavoidable fixed property costs incurred by the business such as rent, rates or mortgage payments, this does not include personal or household costs.
 This should take the form of leases/agreements showing an obligation to pay and bank statements showing that payments have actually been made.
 - Evidence that the business falls within the criteria of those businesses required to close (or partially close) or evidence to demonstrate a substantial loss in income as

a result of the national restrictions. This is likely to be in the form of filed accounts for previous years and management accounts/bank statements for the current period. For example, a minimum of three months bank statements may be required.

- Details of any registration number eg Taxi Drivers.
- Confirmation of State Aid compliance. There is a requirement for all grants made under this scheme to be state aid compliant
- 26. Annual property cost will include rent, mortgage payments, insurance, rates, flexible licence fees.
- 27. If a business is in a sector that has not been allowed to open / trade during the COVID19 crisis or if a business provides services that are not permitted due to social distancing rules, and have not been able to move to online services, the level of income lost will be more significant to that of business still able to operate but at a reduced level. This will be considered in confirming whether a grant is awarded and the grant amount to be offered.
- 28. This application process will allow the Councils to undertake pre-payment checks to confirm eligibility and to allow the individual Council to determine how to use its discretion in relation to the appropriate level of grant.
- 29. The Councils will use their discretion in identifying the right business to receive this funding, based on the application process.
- 30. The Councils will email or write to the business, stating that by accepting the grant payment, they have confirmed they are eligible under the grant scheme, and that any payments accepted will be in compliance with State Aid requirements.
- 31. As a condition of funding we will expect the business applying to sign a declaration stating that they are not committing any fraud and that they are fully complying with any state aid limits, as well as giving the Council permission to share data to check such compliance and that these guidelines are complied with.

Decision Making Process

- 32. Applications will be determined by authorised Council officers, in consultation with Executive Members where appropriate.
- 33. All decisions will be communicated by email or in writing to businesses. Decisions will be made as soon as possible after applications are received, after the receipt of further information if required, and after pre-payment assurance checks have been carried out.
- 34. There is no statutory right of appeal against a decision regarding discretionary business grants. Where a decision is disputed, this will be reconsidered by a different senior officer in consultation where appropriate with an elected member.
- 35. A business can only challenge the grant decision on a point of law through the court.

Payments of Grant and Tax

- 36. All payments of grant will be made by a BACS transfer to the company or business' nominated bank account. Bank accounts will be verified by the Councils counter fraud team.
- 37. These payments are Grants and not Loans, and therefore will not require repayment, unless paid in error or where fraudulent activity is detected.
- 38. Grant income received by a business is taxable therefore funding paid under the Additional Restrictions Grant or the Local Restrictions Support (Open) Grant scheme will be subject to tax.
- 39. Only businesses which make an overall profit once grant income is included will be subject to tax.
- 40. Grant income may also affect the amount of benefit you can or may receive.
- 41. Each Council reserves the right to not award a grant to landlords when evidence suggests the payment is not being passed onto the tenanted business

Liability for Business Rates

- 42. Also all Councils in West Sussex will investigate if any business applying shall be liable for business rates, if not already liable, if applicable. Payment of grant funding to a successful applicant will be conditional on the business paying any business rates liabilities arising from this.
- 43. If the business is liable for business rates and has arrears owed to any West Sussex Council this may stop an additional restrictions discretionary grant being paid. The business may be given the opportunity to clear these arrears.

Managing the risk of fraud

- 44. The Councils will not accept deliberate manipulation and fraud. Any business that dishonestly provides false or misleading information in communication with any Council, including verbal communication, will be committing a criminal offence contrary to the Fraud Act 2006 and will be subject to a criminal investigation and criminal proceedings may be taken against them.
- 45. Conditionality of funding will be dependent on the business agreeing to these conditions by confirmation when they complete their electronic application form.
- 46. Businesses will need to notify their Local Authority if they no longer meet the eligibility criteria for additional grants (for example, if they become insolvent).
- 47. All information is subject to internal and external audit checks.

Sharing Information

48. By applying for a discretionary grant all applicants give authority to the West Sussex Councils to share data for efficient system administration (including within their own

- Authority) and to protect the Public Purse, subject to the Data Protection legislation. This will include sharing data with Sussex and other Local Authorities.
- 49. The Councils will be required to share data with Government Departments for monitoring and other reasons. By applying for a discretionary grant all applicants give authority for this.
- 50. The Councils are also required to provide open data, and be transparent about the use of public funding. In accordance with Data Protection Guidelines, this grant recipient data may be subject to being published on Council's websites.
